



# Southwest Area planning and demographics

### Existing Conditions:

- Population (2010 census)
  = 27,162
- People per acre: 7.7
- Park acres per 1000 people = 2.4
- 2 Community Parks
- 7 Neighborhood Parks

### 2035 GP projections:

- Population = 28,466
- People per acre: 8.1
- Park acres per 1000 people= 3.9
- 3 Community Parks (total combined)
- 15 Neighborhood Parks (total combined)

General Plan Standard is 3.5 acres of city parks per 1000 residents



### Roseland Creek Community Park Summary of all Comments


- The proposed Draft Master Plan reflects a combination of all the comments the City has collected from 2009 – 2018.
- In summary, generally the residents who live nearby the Park wish it to be left in a natural state, with little to no improvement except for trails, a nature center and associated parking.
- Other comments generally include the request for amenities such as;
  - turf for general play, playground, group picnic and regular picnic, dog park, pump track, community garden, restrooms, parking, trails, parking, fitness equipment, basketball, teen center, and an outdoor sink.

### Roseland Creek Community Park Summary of all Comments

- Their have also been requests for more development such as a bicycle velodrome, veterans center, regulation soccer and baseball and requests for absolutely no improvements.
- The plan proposes to protect in place environments that are of special environmental status such as wetlands, purple needle grass and oak woodlands.
- The Draft Concept Plan proposes to balance the varied requests from the community.

# Roseland Creek Community Park Master Plan Process

### Next steps include:

- Review of Concept Plan at SCAPOSD Advisory Committee April 26, 2018
- Detailed Environmental Report to comply with CEQA (6-9 months)
- 30% construction plans to support environmental report
- City Council (late summer early fall 2018)– Adopt Environmental Report and Draft Master Plan

### Adopted Master Plan and Environmental Declaration:

- 100% construction plan of trail connecting McMinn Avenue to Burbank Avenue as required per the Conservation Easement/Agreement with the SCAPOSD
- Obtain Permits, including Environmental and mitigation requirements
- Construction of the trail, including crosswalk at Burbank Avenue

### Roseland Creek Community Park Recommendation

It is recommended by the Recreation and Parks Department that the Board of Community Services review and recommend for approval by City Council the following:

Proposed concept plan for Roseland Creek Community Park Master Plan and associated environmental declaration, including a Nature Center, restroom, parking, trails, interpretive signage, fitness stations, sports courts, picnic areas, group picnic areas with sink, play area, multi-use turf, active use area, hydration stations, site furnishings, split rail fencing, entry gates and crosswalk.
