RECOMMENDATION

It is recommended by the Department of Housing and Community Services that the Housing Authority hold a study session to receive information regarding the resources in the Housing Choice Voucher program that may be leveraged to address critical housing needs in Santa Rosa, including homelessness and an affordable housing shortage. This item is for information only and no action will be taken during the study session; staff will seek direction for future agenda items.

EXECUTIVE SUMMARY

The purpose of this study session is to provide information regarding the resources in the Housing Choice Voucher program that may be leveraged to address critical housing needs in Santa Rosa, including homelessness and an affordable housing shortage.

BACKGROUND

The Housing Choice Voucher (HCV) program is a rental assistance program funded by the Department of Housing and Urban Development (HUD). The program is administered locally by the staff of the Department of Housing and Community Services (HCS) as the Public Housing Authority (PHA) and is overseen by the Housing Authority Board of Commissioners.

Where federal regulations allow, the Board of Commissioners approves the policies of the local program through the Administrative Plan. This study session will highlight policy areas under PHA control related to Waiting List preferences and the use of Project-Based Vouchers in Santa Rosa.
