SUBJECT: APPOINTMENTS TO THE SONOMA COUNTY LIBRARY

<u>RECOMMENDATION</u>

It is recommended that the Council, by motion, make appointments for one City representative and one joint City/County representative to the Sonoma County Library Commission each to sever a four-year term to expire August 1, 2022?

EXECUTIVE SUMMARY

The City of Santa Rosa as well as all cities in Sonoma County are members of the Joint Powers Agreement with the County of Sonoma for County-wide library services. Each member appoints a representative to the Library Commission. The City of Santa Rosa and the County of Sonoma selects an additional jointly appointed representative to the Commission. Goal: Foster neighborhood partnerships and strengthen cultural assets.

BACKGROUND

The Sonoma County Library was established in 1975 with a Joint Powers Agreement (JPA) between the County of Sonoma and the cities of Healdsburg, Petaluma, Sonoma, and Santa Rosa.

Under the 1975 JPA, the Sonoma County Library is governed by a seven-member Library Commission comprised of one member representing each of the five supervisorial districts, one member representing the City of Petaluma, and one member representing the City of Santa Rosa.

In 2012, the Board of Supervisors approached the Sonoma County Mayors and Council Members, who agreed to initiate a review of the JPA in light of challenges at the Library and changes in demographics, technology, and finances.

On April 29, 2014, the City Council approved a First Amended and Restated Joint Powers Agreement for the County-wide Provision of Library Services (Amended JPA) by the Sonoma County Library. Among other things, the Amended JPA expands the

membership of the Library Commission to include all cities and the County, with each member having one vote on the new Library Commission and adds an additional seat to be shared and jointly appointed by the City of Santa Rosa and the County of Sonoma.

In July 2014, Council appointed David Ebright as the City's representative and in August 2014, Council appointed Linda Garcia as the City/County representative. The terms for Mr. Ebright and Ms. Garcia expired on August 1, 2018.

PRIOR CITY COUNCIL REVIEW

ANALYSIS

For the joint City/County appointment, the Amended JPA states that the City and County will advertise the vacancy, accept applications, review the applications, and forward them to the Mayor of the City of Santa Rosa and the Chair of the Sonoma County Board of Supervisors for consideration. Interviews may be conducted if deemed appropriate. The Mayor and Chair then jointly recommend one Commissioner candidate to the Sonoma County Board of Supervisors and the Santa Rosa City Council for approval, which shall not be unreasonably withheld. Should the selected candidate not be approved, the Mayor and Chair would jointly recommend subsequent candidate(s) until a candidate is approved by the City Council and Board of Supervisors.
