

RESOLUTION NO. RES-2018-159

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING AND ADOPTING REPORT FOR PROPOSAL TO PLACE STORM WATER AND DRAINAGE CHARGES ON SONOMA COUNTY PROPERTY TAX ROLL FOR COLLECTION WITH COUNTY PROPERTY TAXES – FISCAL YEAR 2018-2019 AND ORDERING THAT CITY’S ANNUAL STORM WATER ENTERPRISE CHARGES BE COLLECTED ON THE SONOMA COUNTY PROPERTY TAX ROLL UNLESS THOSE CHARGES DO NOT MEET THE COUNTY MINIMUM OF \$10 AND/OR PARCEL OWNER CONTACT INFORMATION IS KNOWN TO BE INCORRECT

WHEREAS, a report, as described in Health and Safety Code section 5473, titled “Report for Proposal to Place Storm Water Enterprise Charges on the Sonoma County Property Tax Roll for Collection with County Property Taxes – Fiscal Year 2018-2019” (Report) was filed with the Santa Rosa City Clerk; and

WHEREAS, notice of the filing of the Report and of the time and place of a hearing on the Report was given by publication as required by Health and Safety Code section 5473.1, together with the proposal (Proposal) that annual charges of the City’s Storm Water Enterprise for the 2018-2019 fiscal year be collected on the Sonoma County Property Tax Roll in the same manner, by the same persons, and at the same time as, together with and not separately from, County property taxes; and

WHEREAS, it is in the best interests of the City that those parcels not billed by the County due to the charges not meeting the County’s \$10 minimum to bill and/or parcels with known incorrect owner contact information shall not be separately billed by the City; and

WHEREAS, any charges not collected will not affect other parcel charges; and

WHEREAS, on September 17, 2018, the noticed public hearing was opened and all previously-filed written protests to the Report and the Proposal were presented to the Council and opportunity was given to all present to speak and to present written or oral protests to the Report and Proposal to place the charges on the Sonoma County Property Tax Roll for collection, as described; and

WHEREAS, following the close of the public hearing, the Council considered the protests presented and determined that the value of the protests, oral and written, did not constitute a majority protest of the Report and the Proposal.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa adopts the Report and the charges as set forth in the Report, which are based on the Equivalent Residential Unit calculated amount and method previously approved by the Council.

BE IT FURTHER RESOLVED that the Council directs the City Clerk to file with the Sonoma County Auditor-Controller-Treasurer-Tax Collector a copy of the Report, as adopted, with a statement endorsed on the Report over the City Clerk’s signature that the Report has been

adopted by 2/3 majority vote of the Council. The Sonoma County Auditor-Controller-Treasurer-Tax Collector shall enter the amounts of the charges set forth in the Report against the respective lots or parcels of land as they appear on the current Sonoma County Property Tax Roll and the charges shall be collected in the same manner, by the same persons, and at the same time as, together with and not separately from, County property taxes for the 2018-2019 fiscal year, unless those charges do not meet the county minimum of \$10 and/or parcel owner contact information is known to be incorrect.
