

**FIRST AMENDMENT  
TO GENERAL SERVICES AGREEMENT NUMBER F001536  
WITH SOILAND COMPANY, INC.  
DBA GRAB N GROW SOIL PRODUCTS**

This First Amendment to Agreement number F001536, dated October 31, 2017 ("Agreement") is made as of this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between the City of Santa Rosa, a municipal corporation ("City"), and Soiland Company, Inc., dba Grab N Grow Soil Products ("Contractor").

**RECITALS**

- A. City and Contractor entered into the Agreement for Contractor to provide delivery of ground green material to the Laguna Treatment Plant Compost Facility.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the agreement for a one year period with no increase to unit price, and increase compensation.

**AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional one year.

3. COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$90,000 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$180,000. The Chief Financial Officer is authorized to pay all proper claims from Charge Number 130807."

All other terms of the Agreement shall remain in full force and effect.
