

Dear Cannabis Policy Subcommittee Members and City Staff:

I am writing to you on behalf of my client, NKM Enterprises (hereafter "NKM"), who is otherwise known as "TSO Sonoma." NKM submitted an application for a cannabis retail facility at 468 Yolanda Avenue, and because there were additional cannabis retail applications submitted within 600 feet of NKM, my client's application was scored based on the review criteria that had been set by City Council.

In at least three separate instances, the city staffer(s) conducting the review of NKM's application overlooked information that was provided. For example, on NKM's Merit Based Review Score-sheet that was published by the city, there is a comment that says Applicant did not clearly demonstrate staff experience in the North Bay cannabis retail industry when, in fact, my client did discuss this information on page 21 of the application narrative. Another comment states that details about compliance were not provided; yet this is a subjective determination—NKM provided a signed statement of compliance addressing all of the critical areas, and they have since hired my law firm to provide ongoing compliance support. Finally, one comment says that NKM did not address bicycle parking and access to transportation, when that information is clearly contained on pages 17-19 of my client's application narrative, as well as on their architectural drawings and in "Exhibit F – Transit Map and Transit Stops" which they provided along with their application (attached here for your reference). These oversights almost certainly resulted in NKM Enterprises receiving a lower score than should have been given.


I kindly ask that you take this information into consideration when deciding which retail applicant(s) in NKM's concentration area will continue on to the next stage of the licensing process. I am confident that NKM Enterprises represents the type of compliant, responsible, and locally-minded cannabis operator that the City of Santa Rosa is looking for.




