1. 4:30 PM CALL TO ORDER AND ROLL CALL

Chair Burch called the meeting to order at 4:34 pm.

2. APPROVAL OF MINUTES

3. BOARD BUSINESS

Chair Burch read aloud the Design Review Board Statement of Purpose.

Statement of Purpose: Zoning Code Chapter 20-52.030 F. Project Review. The review authority shall consider the location, design, site plan configuration, and the overall effect of the proposed project upon surrounding properties and the City in general. Review shall be conducted by comparing the proposed project to the General Plan, any applicable specific plan, applicable Zoning Code standards and requirements, consistency of the project within the City's Design Guidelines, architectural criteria for special areas, and other applicable City requirements (e.g., City policy statements and development plans.)

Chair Burch opened Public Comments.

Duane De Witt (Roseland) - Need better noticing for public meetings, agenda updates, and project planner changes. The

City requires open space/parks, but Roseland has higher density and few parks/open space - consider tiger salamanders in the process. Staff needs to get good background material early in the planning process.

PRJ18-003 (CUP18-005/DR18-005) BACKGROUND: Applicant proposes construction of a 54-foot tall faux steeple, with a twelve-foot by twelve-foot footprint, attached to the Community Baptist Church building and a screened ground-mounted equipment area in a nearby fully contained lease area adjacent to the church building.

Wes Daniels - Opposed the project due to the amount of existing cell towers in his neighborhood. Expressed concern regarding the scale of the steeple. Asked that the scale be reduced to match St Eugene's.

Alison Chandler - 1625 Sonoma Ave - Concurred with Daniels re scale of project.

Chair Burch closed the public hearing at 5:07 pm.

Applicant Representative Gerie Johnson gave a presentation.

The Civil Engineer answered the Board's questions.

Wes Daniels asked the Board a question regarding size of steeple.

The Board encouraged the design team to review: 1.) Redesign of steeple with smaller footprint to be as close to original 8-foot by 8-foot size as possible. 2.) Include redesign to include materials authentic to the church at the lower level of the steeple, using real materials (not faux), and add detail/variation, and openness at various levels of the steeple 3.) Encourage redesign to include a variety of materials and details with some openings or changes of surface plane.

A motion was made by Board Member Weigl, seconded by Board Member Zucco, continue to December 20, 2018 - COMMUNITY BAPTIST CHURCH - FAUX STEEPLE AND BUILDING-MOUNTED MINOR TELECOMMUNICATION FACILITY - DESIGN REVIEW MINOR - 1620 SONOMA AVE - FILE NO(S.) PRJ18-003 (CUP18-005/DR18-005. The motion carried by the following vote:
