### RECITALS

- A. City and Contractor entered into the Agreement for Contractor to address all areas of permitting, building, plan review, inspection, recovery, outreach and communication needs resulting from the Northern California wildfires.
- B. City and Contractor now desire to amend the Agreement for the purpose of increasing compensation and updating the Contractor staff cost proposal by revising the classifications required to conduct the services described above and set forth in Exhibit A.

### AMENDMENT

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Exhibit B to the Agreement is replaced by Exhibit B-1 to this Amendment.

Section 2(c) is amended to increase the compensation payable to Contractor under the Agreement by \$377,052 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of nine million two hundred sixty three thousand two hundred twelve dollars and no cents (\$9,263,212). The City's Chief Financial Officer is authorized to pay all proper claims from Charge Number 08046."

All other terms of the Agreement shall remain in full force and effect.
