## RECOMMENDATION

It is recommended by the Planning and Economic Development Department that the Council, by Resolution, accept a \$50,000 donation from the Rotary International District 5130 Sonoma County Fire Relief Fund for the Coffey Park Public Art Project.

# **EXECUTIVE SUMMARY**

The donation from the Rotary International District 5130 Sonoma County Fire Relief Fund will be used for the commission, construction and installation of public art at Coffey Neighborhood Park, located at 1524 Amanda Place, Santa Rosa, California.

### **BACKGROUND**

The City of Santa Rosa Public Art Program has been working with the Recreation and Parks Department and the selected design team for the rebuild of Coffey Neighborhood Park to include public art in the Park. The available Public Art Funding for the art project is \$50,000. This generation donation of \$50,000, paired with the Rotary Club of Santa Rosa West donation of \$10,000 has allowed for a much more robust project with a total project budget of \$110,000. The selected artists will design, fabricate and install public art in Coffey Neighborhood Park, in conjunction with the redesign/rebuild of the park.

Rotary International District 5130, a non-profit organization, formed a Fire Relief Fund

for Sonoma County with a mission to provide help in the most efficient and effective way to those devastated by the 2017 wildfires. The Rotary International District 5130 Sonoma County Fire Relief Committee approved a \$50,000 donation to the City of Santa Rosa Public Art Fund to be used for the Coffey Park Public Art Project. The panel selecting the artist for the project included a representative from Rotary International District 5130. The receipt of the donation will be acknowledged by the City of Santa Rosa through the installation of a plaque at the project site depicting the Rotary logo and the words "This project funded in part by a grant from the Rotary District 5130 Fire Relief Fund."

### FISCAL IMPACT

Approval of this action does not have a fiscal impact on the General Fund. Funding for the Coffey Park Public Art Project and the subsequent maintenance of the artwork comes from the Public Art Fund.

### **ENVIRONMENTAL IMPACT**
