This could have potentially identified the vandals or at the very least, deterred them from committing the crime. When I filed the police report, I was advised by the officer that law enforcement in that area is stretched thin. Having surveillance equipment at that intersection would help thwart crime and have a positive impact upon the immediate neighborhood. After speaking to the owner and representatives of Mercy, I am convinced that Mercy will be a good neighbor and positive community partner. I hope that you will consider this facet as you determine whether to grant Mercy a business permit.
