Dear Ms. Murray,

As a resident of the Santa Rosa community and property owner at 526 Earle Street, I am writing this letter to advise you of my support for Mercy Wellness being granted a conditional use permit to operate a cannabis retail business at 900 Santa Rosa Avenue.

The following incident happened last month.

On Thursday, July 18, 2019 at approximately 11:00 pm, my property was defaced with a half dozen bright orange paint balls. While this may seem to be a rather benign crime, the vandalism caused me time, money and hardship, as I recently spent my savings on painting the house. I spoke to Ryan O'Kelly at Mercy about the incident. He assured me that had Mercy been actively conducting business at 900 Santa Rosa Ave, security monitors would have been installed and active. This could have potentially identified the vandals or at the very least, deterred them from committing the crime. When I filed the police report, I was advised by the officer that law enforcement in that area is stretched thin. Having surveillance equipment at that intersection would help thwart crime and have a positive impact upon the immediate neighborhood. After speaking to the owner and representatives of Mercy, I am convinced that Mercy will be a good neighbor and positive community partner. I hope that you will consider this facet as you determine whether to grant Mercy a business permit.
