Dear Ms Murray,

I received the Public Hearing announcement for the cannabis dispensary at 900 Santa Rosa Ave. I see there is also a rezoning part to this application. I have a few questions.

1. What is the zoning now?

Response: The current zoning is PD (Planned Development); the property is within the South Park Planned Development area.

2. What does the new zoning of General Commercial mean as far as new retail businesses?

Response: Rezoning the subject property, as well as an additional 33 properties located along the east side of the Petaluma Hill Road, into the CG zoning district will allow mixed use, multifamily residential, and retail & commercial uses. It won't allow new heavy industrial uses. Here's a link the to Land Use Table for that district: [http://qcode.us/codes/santarosa/view.php?topic=20-2-20\\_23&showAll=1&frames=on](http://qcode.us/codes/santarosa/view.php?topic=20-2-20_23&showAll=1&frames=on). Refer to Table 2-6.

3. Why not make this neighborhood mixed use, so you can have the retail/commercial but also have housing above?

Response: That's exactly what we're doing by changing the zoning district. Again, refer to the allowable land uses in Table 2-6.

Thank you. I have wanted the derelict buildings along that stretch of Santa Rosa Ave and the decrepit buildings on South A and Barham Avenue rezoned for housing or mixed use. Although this area of town is not officially in the Downtown Station Area Plan, this is a possible neighborhood in the future -- an extension of the Earle Street Historic Neighborhood.

Thank you for your time. I look forward to more information about these zoning changes.
