This is to inform you that the City of Santa Rosa CityBus intends to apply for federal funds under the Federal Transit Administration Elderly and Disabled Transit Program (Title 49 U.S.C. Section 5310) administered by the California Department of Transportation (Caltrans).

A public hearing is required to allow private non-profit agencies to demonstrate whether they are readily available to provide paratransit service. **Readily Available** is defined as "interested, willing and capable of providing the proposed service at a comparable cost to the identified clientele, in the same service area, with the same hours of frequency, and at the same level of service." If nonprofit agencies are not readily available to carry out the proposed service, then the public agency (City of Santa Rosa CityBus) becomes eligible to apply for the funding.

Attached is a copy of the notice that will be published in the Press Democrat on August 8, 2019.

The Public Hearing will be held on Tuesday, August 27, 2019 at or after 5pm at the City of Santa Rosa City Council meeting.
