AGENDA ACTION: ORDINANCE AND RESOLUTION

RECOMMENDATION

It is recommended by the City Clerk that the Council adopt an ordinance of the Council of the City of Santa Rosa adding Chapter 11-26 to the Santa Rosa City Code, authorizing preferential parking in designated areas of Santa Rosa, introduced at the August 13, 2019, Regular Meeting by a (5-0-2) vote; and by resolution, adopt a revised schedule of parking user fees, adding a permit rate for preferential parking in designated areas of the West End of Santa Rosa, effective October 1, 2019.

EXECUTIVE SUMMARY

This ordinance, introduced at the August 13, 2019, Regular Meeting by a (5-0-2) vote (Council Members Sawyer and Tibbetts absent), adds Chapter 11-26 Preferential Parking to the City Code to establish an on-street employee permit program. This resolution to adopt a revised schedule of parking user fees and adding a permit rate for preferential parking in the designated areas of the West End of Santa Rosa was also presented at the August 13, 2019, Regular Meeting, but no motion was made to move the resolution.

BACKGROUND

In late 2018, the City received a request to install 3-hour time limit parking signs on portions of West 6th Street and on Adams Street, to improve access to parking spaces and create turnover. The City reached out to the adjacent businesses for feedback and received no negative comments. In early 2019, the City installed 3-hour time limit signs on those streets. After a few months, the City began receiving complaints from several businesses located in the vicinity of the newly time restricted area stating that their employees were no longer able to find places to park and requested the City provide a solution to address their needs.

Both the ordinance and resolution were presented to Council as a Public Hearing at the August 13, 2019 Regular Meeting, but only the ordinance was moved.

FISCAL IMPACT

It is expected that 50 - 100 permits will be sold, generating annual revenue of \$15,000 to \$30,000 to the General Fund, which will offset costs to install the new signage and administer the program.
