- Proposed text amendments to Zoning Code Chapter 20-16, Resilient City Development Measures
  - ✓ Add a second, automatic, 12-month extension
    - ✓ Tentative maps and associated entitlements
  - ✓ Address housing needs Citywide following the fires of October 2017





- October 2016: Council accepted Housing Action Plan, addressing ongoing unmet housing needs
- June 2017: Council priorities adopted implementation of comprehensive housing strategy
- October 2017: Fires damaged or destroyed approximately 3,000 homes and 100 commercial structures – local emergency proclamation and Resilient City (-RC) District created
- December 2017: Council study session regarding Resilient City Ordinance
- April/May 2018: Council adopted Resilient City Development Measure Ordinance





- October 2016: Council accepted Housing Action Plan, addressing ongoing unmet housing needs
- June 2017: Council priorities adopted implementation of comprehensive housing strategy
- October 2017: Fires damaged or destroyed approximately 3,000 homes and 100 commercial structures – local emergency proclamation and Resilient City (-RC) District created
- December 2017: Council study session regarding Resilient City Ordinance
- April/May 2018: Council adopted Resilient City Development Measure Ordinance No. ORD-2019-001




### a Rosa Ordinance: Automatic 12-Month Extension

- ✓ Tentative subdivision maps, vesting tentative subdivision maps and tentative parcel maps that were valid on October 9, 2017 and subject to a previous one year extension by City Council Ordinance No. ORD-2019-001t, shall be automatically extended by one year
  - ✓ Applies to 36 subdivisions totaling 975 housing units
  - ✓ Potential for more housing and commercial projects would benefit
- ✓ Discretionary land use approvals that have been approved in conjunction with the above map approval would be automatically extended by one year

- Adoption of the proposed ordinance is exempt from the California Environmental Quality Act (CEQA) pursuant to:
  - ✓ CEQA Section 15061(b)(3) Common sense exemption
  - ✓ CEQA Section 15183 Consistent with community plan, general plan or zoning
