


History

- 1992 Zero Waste Sonoma (SCWMA) Formed
- 1993 A Municipal Composting Facility began Operations in Sonoma County
- Dec 2011 ZWS Released a Draft EIR for a New Compost Facility
- Apr 2013 ZWS Released the Final EIR for a New Compost Facility
- Oct 2015 The In-County, Municipal Composting Facility Closed

More Recent History


- May 2017 ZWS Released RFP for Organics Processing
- July 2017 City of Santa Rosa Released RFP for Facility Location
- Aug 2018 ZWS Selected Renewable Sonoma
- Feb 2019 BPU Authorized an ENA with Renewable Sonoma



The City's Biosolids Program




32,600 tons of Biosolids/yr Totaling \$2,166,000/yr

Request for Proposals for Biosolids Processing

- Process Approximately 11,000 tons of Biosolids per year
- From November 1st April 30th
- For 5-year Base Term
 with (2) 3-year Extensions

Request for Proposals - Review

- 2 Proposers
- Unanimous Selection based on Technical Proposal
 - Flexibility with Material Acceptance
 - Increases Diversity of City's Disposal Profile
 - Closer Facility = Shorter Hauling Distance
 - More Robust Contingency Plan
- Proposers have been Notified and Negotiations with Highest Ranked Proposer will Begin

- February 27th CC/BPU Liaison to Consider/Recommend to BPU:
 - Draft Biosolids Processing Agreement
 - Organics Processing Facility Location
- Staff will Review
 - Organics Processing Facility Project Review/Approval Process

 - Staffing Plan
 - Additional Information as Requested

- Pre-Development Agreement(s) with Renewable Sonoma
- Conceptual Site Plan/Project Description Development

- CEQA/Permitting
- Design/Construction/Commissioning
