Dear Deputy Director Hartman,

I am responding to a postcard regarding the subject project. I am a former resident of JEMHP and I am unable to attend the meeting on January 14th, however, would like you to be aware of my hopes and concerns as it relates to the closure of JEMHP and plans for the future of that location.

It is my understanding that the owner, Mr. Shuayto, in partnership with Burbank Housing, plans to rebuild "affordable housing" on that lot and that those of us who were forced to relocate due to Tubbs Fire would have first option to live in the new units. I want the Santa Rosa City Council Planning Department to know that I do hope to be able to return to that location, and to hear my concerns that the term "affordable" is ambiguous and "below market rate" is also ambiguous, because the demand for housing in Sonoma County is high.

The location of JEMHP was chosen by me and my husband in 2014 as the ideal retirement spot for several reasons. First, affordability - lot rental was \$475 in 2014 and was under rent control, so we were confident that even with annual increases, we would be able to afford to live there for the rest of our lives. Second, convenience - every necessity was within walking distance, and there was a bus stop on Mendocino Avenue. Third, environment - it was a beautiful location with clean air and many lovely places to visit nearby.

I dearly miss our walks in the Armstrong Redwood Forest and the many nature trails in Sonoma County. I miss our drives on River Road and the Bohemian Highway. I miss photographing vineyards and the coast. I very much want to return to that location, and hope that you will see to it that as many of us - neighbors who were forced out of our precious retirement community by that horrendous fire - who are able to return will return to live in the new units. My fear is that ambiguity of "affordable" and "below market rate".

I am writing to ask you to do all you can to oversee the new construction so that it is done in the interest of the senior citizens who lost our community on October 9, 2017. Please do not allow greed to steer this project off track. Sonoma County needs affordable housing, and we who wish to live in that spot deserve consideration.

Please see to it that the new units are built with us in mind. My last check to JEMHP was for \$694.78 (attached). Mr. Shuayto refunded all of the October rent. We sincerely hope to return to that location in Santa Rosa in the near future and are counting on the City Council to make sure this project stays on track to be affordable housing for the senior citizens who lost our community due to that disaster.
