

Dear Ms. Hartman,

Dave Parmenter and I are former tenants at the above park, 474 Paramount Street was our address. Our mobile was a total loss in the Tubbs Fire. For the past two years, we have been living in a garage with no bathroom or kitchen in Mendocino county because housing in Santa Rosa was virtually impossible to secure in the madness after the fire. I lost my job in Healdsburg and work up here is scarce and low-paid. I am taking Social Security early due to this unfortunate situation. I lost EVERYTHING in the fire, except thank goodness my partner and two cats.

We are unable to attend the above meeting. I am viewing the agenda online, and will do the same after the meeting is finished. We have been told that the JE is the last item on your agenda, which usually means hours of waiting and sitting. We live 1.5 hours north of Santa Rosa and are senior citizens who do not drive well in the dark, especially when it is raining. This may be the case for the evening of your meeting.

During our tenure at JE, I dealt with extreme situations of drug dealing and dealers on the street behind us. This went on for two years. I was very involved with the managers and police; as a result, the woman who was doing the worst of it threatened us constantly and we lived in fear; we had to arm ourselves because nothing was being done about her and her partners in the park. I have no desire to live in another mobile home park near there as very probably the same thing is going on in those places as well.

Mr. Parmenter and I firmly believe that we should be eligible for any and all assistance provided to those who lost their homes. We have been told that the amount will be around \$4,500. Frankly, there are a few of us from the Park who deserve more due to the horrible extenuating circumstances that we suffered while living there; we risked our lives to protect ourselves and the Park.

I will be watching your website to see when the payments will be made. In the meantime, I would like to give our sincerest, heartfelt thanks to Howard Tong at the Buddhist Foundation for his continual support through this nightmare. He and his people have been remarkable.


