The board discussed site plan, stacked housing (4-stories), affordability, unit size, well location, residential access to sidewalk at Highway 12, siding and other building materials, building colors-especially at storage units, glazing, roof pitch, 4-sided architecture, building mass and breaking up of mass through design, units at creekside, reflective materials, parking, possibly eliminating garages for additional density. Landscaping is critical.

6.2 CONCEPT DESIGN REVIEW - GUERNEVILLE RD SUBDIVISION 1665 GUERNEVILLE RD - FILE NO. DR18-036
BACKGROUND: The project proposes a 12-unit small lot subdivision on
the approximate one-acre site. Each lot is proposed to be developed
with a two or three-story, attached single-family dwelling. Three of the
lots are proposed to contain an accessory dwelling unit. A new private
road that would be provided down the center of the property would
provide access to the proposed dwellings
