Dear Planning Commissioners,

We have received the two attached e-mails regarding Item 9.1 on today's agenda. In response, please note that the recommended action today for this item will not in any way change the tentative map or any related permits as it was previously approved for time extensions on February 22, 2018.

The Kerry Ranch I Tentative Map Time Extension you will consider at today's meeting is only an extension of the expiration date for one (1) year – the map and its conditions related to the use of Parcel A will remain unchanged from the most recent Commission action on February 22, 2018. If approved today as recommended by staff, the expiration date of the Kerry Ranch 1 tentative map would be extended to December 4, 2020.

Here is what I had written up....

Hi Al!

You are on the right track, but if you look a little further at the attached and approved Resolutions for both Extension 1 and Extension 2 approved by the Planning Commission on February 22, 2018, you will see that the change to the conditions of approval was made in fact--I've attached them both for you to have for your records. Here is what the approved condition regarding Parcel A said then:

And here is what we are currently recommending for tomorrow's meeting in the staff report resolution to approve the tentative map extension related to Parcel A:

As you can clearly see, there is no change.

Further, to insure we avoid any confusion over the time extension and expiration dates, the current Planning Commission report for tomorrow's meeting is correct to say that staff recommends that the tentative map be extended 1-year from December 4, 2019 to December 4, 2020. In fact, the previous Resolution 2 from February 22, 2018, said this...

Before the expiration of this map on December 18, 2018, the City Council adopted Resilient City Measures that automatically extended all tentative maps that had not expired as of October 9, 2017 and their related permits for another year, including this tentative map. As such, this map would have expired on December 4, 2019. Thus, the application to extend the tentative map that the Planning Commission will consider at tomorrow's meeting would extend the tentative map another year, until December 4, 2020, if approved.

Of course you are free to voice your concerns as you wish at the Planning Commission meeting, but I also want to be clear that staff is simply recommending the Planning Commission use previously approved map extension conditions of approval as it relates to Parcel A, we are not recommending any changes at this time related to the use of Parcel A. This is confirmed in the attached Resolutions approved by the Planning Commission on February 22, 2018, which was a noticed public hearing.

We will certainly take under advisement your concerns and I have forwarded this message to Mr. Guhin, Ms. Hartman, Mr. Rose and Mr. Osborn.

Hi Michael,

Enclosed is the 5-page Planning Commission 2-22-2018 meeting minutes. Pages 4 and 5 address Kerry Ranch 1. Kerry Ranch 1 was granted two 12 months extensions, therefore I assume their Tentative Map is good to 2-22-2020.

However, look at the Background Summary of this item. There is <u>no mention of any changes</u> in the Tentative Map that would yield 30 lots and delete the wildlife-storm drainage retention area (Parcel A) nor was there any discussion on this topic recorded in the minutes. How would anyone from the neighborhood know this was happening??? We learned by accident last summer (2019) when Dan Morgan submitted a 1 into 5 subdivision for Parcel A (see Adam Ross) and the City held a neighborhood meeting.

So, I would encourage you to reference the above information when you address the Planning Commission on the Tentative Map Extension tomorrow. I stand by my recommendation that a "Tentative Map modification is in the works" and should be handled via appropriate notice to the neighborhood of a Public Hearing on this matter followed by a scheduled Public Hearing.

Please share this and other information we have discussed on Kerry Ranch 1 with David Guhin as I have a voice mail in with him
