My name is Keira Engdahl and have recently been exposed to the Sonoma County lifestyle of living in fear. Fires and floods have destroyed the paradise that Sonoma County once was. The fires of 2017 and 2019 caused the population to feel scared during the entirety of "fire season". I live in Novato, Marin County and luckily, my family hasn't been directly affected by either of the major fires yet. The fire that burned a total of nine acres was just across the highway from my house and that was one of the most nerve wracking experiences of my life. Nine acres was nothing compared to the 77,758 acres burned in the most recent and devastating Kincade Fire. I can't even begin to imagine the amount of stress and adrenaline coursing through the veins of someone that's woken up at 4:00am to get evacuated from their home. An entire life's belongings shouldn't have to be packed into a suitcase and driven somewhere "safe". During the devastation of the Tubbs fire, I was basically unaware as to how intense these fires can get. This fire was sadly in a very densely populated area and it burned 5,643 structures. This was before I had to commute by train to Sonoma everyday so I had yet to realize that Santa Rosa and Napa County were a lot closer to home than I thought. I vividly remember sitting in the car with my father going to my middle school in San Rafael and asking him, "Dad, why is the sun red?" The sun was covered in smoke.

Climate change in our world is clearly happening and in order to make any difference, we have to start somewhere. Choosing to use local, renewable power only, will reduce the human element of the exacerbated natural disasters that the county has already seen.
