#### CITY OF SANTA ROSA GENERAL SERVICES AGREEMENT WITH MATRIX HG, INC AGREEMENT NUMBER F002071

This "Agreement" is made as of this \_\_\_\_\_day of \_\_\_\_\_\_2020, by and between the City of Santa Rosa, a municipal corporation ("City"), and Matrix HG, Inc., a California Corporation ("Contractor").

#### RECITALS

A. City desires to contract for HVAC maintenance services as needed by the City.

B. City desires to retain a qualified contractor to conduct the services described above in accordance with the terms of this Agreement.

C. Contractor represents to City that it is fully qualified to conduct the services described above.

D. The parties have negotiated upon the terms pursuant to which Contractor will provide such services and have reduced such terms to writing.

#### AGREEMENT

NOW, THEREFORE, City and Contractor agree as follows:

#### 1. SCOPE OF SERVICES

Contractor shall provide to City the services described in Exhibit A ("Scope of Services") and Exhibit B (HVAC Unit List). Contractor shall provide these services at the time, place, and in the manner specified in Exhibit's A and B. Exhibit's A and B are attached hereto solely for the purpose of defining the manner and scope of services to be provided by Contractor and is not intended to, and shall not be construed so as to, modify or expand the terms, conditions or provisions contained in this Agreement. The parties agree that any term contained in Exhibit's A and B that adds to, varies or conflicts with the terms of this Agreement is null and void.

#### 2. TIME FOR PERFORMANCE

The services described herein shall be provided commencing February 1, 2020 through January 31, 2022. Contractor shall devote such time and effort to the performance of services as is necessary for the satisfactory and timely performance of Contractor's obligations under this Agreement. Neither party shall be considered in default of this Agreement, to the extent that party's performance is prevented or delayed

# 3. STANDARD OF PERFORMANCE

Contractor shall perform all services required under this Agreement in the manner and according to the standards currently observed by a competent practitioner of Contractor's occupation in California. All products and services of whatsoever nature that Contractor provides to City pursuant to this Agreement shall conform to the standards of quality normally observed by persons currently practicing in Contractor's occupation, and shall be provided in accordance with any schedule of performance specified in Exhibit's A and B. Contractor shall assign only competent personnel to perform services pursuant to this Agreement. In the event that City, at any time during the term of this Agreement, desires the removal of any person assigned by Contractor to perform services pursuant to this Agreement, because City, in its sole discretion, determines that such person is not performing in accordance with the standards required herein, Contractor shall remove such person immediately upon receiving notice from City of the desire of City for the removal of such person.

#### 4. COMPENSATION

The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in Exhibit's A and B shall not exceed the total sum of \$112,842.84. The Chief Financial Officer is authorized to pay all proper claims from various Charge Numbers.

#### 5. BILLABLE RATES, PAYMENTS TO CONTRACTOR

a. Billable Rates. Contractor shall be paid for the performance of services at rates set forth in Addendum to Exhibit C.

b. Payments. Payments will be delayed where Contractor fails to provide the information required under subsection c. below or fails to comply with the insurance requirements in Attachment One to this Agreement. In no event shall the City be obligated to pay late fees or interest, whether or not such requirements are contained in Contractor's invoice.

c. Invoices. Payment will be made on a calendar-month basis in arrears. Invoices shall be submitted to the person and address specified in the Agreement, bid, or purchase order. In the event this Agreement becomes effective or terminates during the course of a month, the amount paid to the Contractor for the partial month shall be determined by prorating the amount on the basis of the number of calendar days involved. Processing of payment will be delayed for Contractor's failure to include reference to Agreement (including number) on the invoice <u>and for failure to maintain current insurance information with the City in accordance with insurance requirements hereunder.</u> In no event shall City be obligated to pay late fees or interest, whether or not such requirements are contained in the Contractor's involce. Invoices for services provided in June or for any services not previously

involced shall be submitted within 10 working days after June 30 to facilitate City fiscal year end closing. Fallure to comply with this invoice submission requirement may delay payment.

In connection with any cash discount specified in the bid response, if applicable, or Contractor's Proposal, time will be computed from the date correct invoices are received by the person and address specified in the Agreement, bid, or purchase order. For the purpose of earning the discount, payment is deemed to be made on the date of mailing of the City warrant or check. All invoices shall contain the following information:

- 1. Contractor name and remittance address
- 2. Date of invoice issuance
- 3. Amount of invoice
- 4. City purchase order or Agreement number
- 5. Identification of Agreement or purchase order line item(s) (if multiple lines) and description of services provided
- 6. Date of completion of services
- 7. Detail of costs, including labor, materials, tax, etc.

d. Business Taxes. Contractor shall pay to the City when due all business taxes payable by Contractor under the provisions of Chapter 6-04 of the Santa Rosa City Code. The City may deduct any delinquent business taxes, and any penalties and interest added to the delinquent taxes, from its payments to Contractor.

## 6. TERM, SUSPENSION, TERMINATION

a. The term of this Agreement shall be for two years, commencing on February 1, 2020. City and Contractor may, upon mutual written agreement of both parties, extend this Agreement for up to three (3) additional one-year terms.

b. City shall have the right at any time to temporarily suspend Contractor's performance hereunder, in whole or in part, by giving a written notice of suspension to Contractor. If City gives such notice of suspension, Contractor shall immediately suspend its activities under this Agreement, as specified in such notice.

c. City shall have the right to terminate this Agreement for convenience at any time by giving a written notice of termination to Contractor. If City gives such notice of termination, Contractor shall immediately cease rendering services pursuant to this Agreement. If City terminates this Agreement, City shall pay Contractor the reasonable value of services rendered by Contractor prior to termination. In this regard, Contractor shall furnish to City such information as in the judgment of the City is necessary for City to determine the reasonable value of the services rendered by Contractor. City shall not in any manner be liable for lost profits that might have been made by Contractor had the Agreement not been terminated or had Contractor completed the services required by this Agreement.

## 7. TERMINATION OF AGREEMENT FOR DEFAULT

General Services Agreement Form approved by the City Attorney 8-1-15 If at any time 1) Contractor fails to conform to the requirements of this Agreement; 2) Contractor seeks relief under any law for the benefit of insolvents or is adjudicated bankrupt; 3) any legal proceeding is commenced against Contractor which may interfere with the performance of this Agreement; or 4) Contractor has failed to supply an adequate working force, or materials of proper quality, or has failed in any other respect to prosecute the work with the diligence and force specified and intended in and by the terms of this Agreement, which default is not fully corrected or remedied to the reasonable satisfaction of City within ten (10) days following the date a written notice thereof by City, then City shall have the right and power, at its option and without prejudice to any other rights or remedies it may have, to immediately terminate this Agreement. Any cost or expense incurred by City arising out of Contractor's breach or default hereunder, and for City's discretion, be deducted from any amounts that may then be owing to Contractor under this Agreement, without any release or waiver of any other rights or remedies in law or equily to which City may be entitled.

# 8. INDEMNIFY AND HOLD HARMLESS AGREEMENT

Contractor shall indemnify, defend and hold harmless City and its employees, officials, and agents, from and against any liability, (including liability for claims, suits, actions, arbitration proceedings, administrative proceedings, regulatory proceedings, losses, expenses or costs of any kind, whether actual, alleged or threatened, interest, defense costs, and expert witness fees), where the same results from or arises out of the performance of this Agreement by Contractor, its officers, employees, agents, or sub-contractors, excepting only that resulting from the sole, active negligence or intentional misconduct of City, its employees, officials, or agents. This indemnification obligation is not limited in any way by any limitation on the amount or type of damages or compensation payable to or for Contractor or its agents under workers' compensation acts, disability benefits acts, or other employees' benefits acts. The provisions of this Section 8 shall survive any expiration or termination of this Agreement.

#### 9. INSURANCE REQUIREMENTS

Contractor shall maintain in full force and effect all of the insurance coverage described in, and in accordance with, Attachment One, "Insurance Requirements", which is attached hereto and hereby incorporated herein by this reference. Maintenance of the insurance coverages as set forth in Attachment One is a material element of this Agreement and a material part of the consideration provided by Contractor in exchange for the City's agreement to make the payments prescribed hereunder. Failure by Contractor to (i) maintain or renew coverage, (ii) provide the City notice of any changes, modifications, or reductions in coverage, or (iii) provide evidence of renewal, may be treated by the City as a material breach of this Agreement by Contractor, whereupon the City shall be entitled to all rights and remedies at law and in equity, including but not limited to the immediate termination of this Agreement. Notwithstanding the foregoing, any failure by Contractor to maintain required insurance coverage shall not excuse or alleviate Contractor from any of its other duties or

obligations under this Agreement. In the event Contractor, with approval of the City pursuant to Section 11 below, retains or utilizes any subcontractors in the provision of any services to City under this Agreement, Contractor shall assure that any such subcontractor has first obtained, and shall maintain, all of the insurance coverage requirements set forth in Attachment One.

## 10. LEGAL REQUIREMENTS AND PERMITS; NONDISCRIMINATION

Legal Requirements and Permits. Contractor represents and a. warrants that Contractor has all licenses, permits, City Business Tax Certificate, qualifications, and approvals of whatsoever nature that are legally required for Contractor to practice its occupation and provide services under this Agreement. Contractor shall perform all services described herein in compliance with all applicable federal, state and local laws, rules, regulations, and ordinances, including but not limited to, (i) the Americans With Disabilities Act (ADA) of 1990, (42 U.S.C. 12101, et seq.), and any regulations and guidelines issued pursuant to the ADA, which prohibits discrimination against individuals with disabilities and may require reasonable accommodations; (ii) and Labor Code Sections 1700-1775, which require prevailing wages (in accordance with DIR schedule at www.dir.ca.gov) be paid to any employee performing work covered by Labor Code Section 1720 et seq.; (iii) OSHA; and (iv) the Immigration Reform and Control Act of 1986. Contractor shall, if requested by City, provide certification and evidence of such compliance. If Contractor is an out-of-state corporation, Contractor warrants and represents that it possesses a valid certificate of qualification to transact business in the State of California issued by the California Secretary of State pursuant to Section 2105 of the California Corporations Code.

b. Non-Discrimination. With respect to the provision of goods or services under this Agreement, Contractor agrees not to discriminate against any person because of the race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender expression, age, sexual orientation, or military and veteran status of that person.

# 11. ASSIGNMENT AND SUBCONTRACTING

Contractor shall not subcontract or assign any right or obligation under this Agreement without the written consent of the City. Any attempted or purported subcontract or assignment without City's written consent shall be void and of no effect. No right under this Agreement, or claim for money due or to become due hereunder, shall be asserted against the City, or persons acting for the City, by reason of any socalled assignment of this Agreement or any part thereof and Contractor hereby agrees to indemnify and hold City harmless against any and all such claims. In the event Contractor obtains the prior written consent of City to assign monies due or to become due under this Agreement, Contractor shall provide City a copy of the instrument of assignment duly executed by Contractor, which shall contain a clause subordinating the claim of the assignee to all prior liens for services rendered or materials supplied for the performance of work. Upon notice and request by the City, Contractor shall promptly

remedy, to include termination of any subcontract as appropriate and necessary, any default or failure to perform in a satisfactory manner the work undertaken by any subcontractor. Contractor shall be fully responsible and accountable to the City for the acts and omissions of its subcontractors, and of persons directly or indirectly employed by them, to the same extent that Contractor is for the acts and omissions of persons directly employed by Contractor. Nothing contained in this Agreement shall create any contractual relation between any subcontractor and the City.

## 12. BINDING EFFECT

This Agreement shall be binding on the heirs, executors, administrators, successors, and assigns of the parties, subject to the provisions of Section 11, above.

#### 13. RETENTION OF RECORDS

Contractor shall be required to retain any records necessary to document the charges for the services to be performed under this Agreement and make such records available to the City for inspection at the City's request for a period of not less than four (4) years.

#### 14. ENTIRE AGREEMENT

This document, including all Exhibits and Attachment One, contains the entire agreement between the parties and supersedes whatever oral or written understanding the parties may have had prior to the execution of this Agreement. No alteration to the terms of this Agreement shall be valid unless approved in writing by Contractor, and by City, in accordance with applicable provisions of the Santa Rosa City Code.

## 15. SEVERABILITY

If any portion of this Agreement or the application thereof to any person or circumstance shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected thereby and shall be enforced to the greatest extent permitted by law.

#### 16. WAIVER

Neither City acceptance of, or payment for, any service performed by Contractor, nor any waiver by either party of any default, breach or condition precedent, shall be construed as a waiver of any provision of this Agreement, nor as a waiver of any other default, breach or condition precedent or any other right hereunder.

## 17. ENFORCEMENT OF AGREEMENT

This Agreement shall be governed, construed and enforced in accordance with the laws of the State of California. Venue of any litigation arising out of or connected with this Agreement shall lie exclusively in the state trial court located in Sonoma

General Services Agreement Form approved by the City Attorney 8-1-15 County in the State of California, and the parties consent to jurisdiction over their persons and over the subject matter of any such litigation in such court, and consent to service of process issued by such court.

## 18. CONTRACTOR NOT AGENT

Except as City may specify in writing, Contractor and Contractor's personnel shall have no authority, express or implied, to act on behalf of City in any capacity whatsoever as an agent. Contractor and Contractor's personnel shall have no authority, express or implied, to bind City to any obligations whatsoever.

## **19. INDEPENDENT CONTRACTOR**

a. It is understood and agreed that Contractor (including Contractor's employees) is an independent contractor and that no relationship of employer-employee exists between the parties hereto for any purpose whatsoever. Neither Contractor nor Contractor's assigned personnel shall be entitled to any benefits payable to employees of City. City is not required to make any deductions or withholdings from the compensation payable to Contractor under the provisions of this Agreement, and Contractor shall be issued a Form 1099 for its services hereunder. As an independent contractor, Contractor hereby agrees to indemnify and hold City harmless from any and all claims that may be made against City based upon any contention by any of Contractor's employees or by any third party, including but not limited to any state or federal agency, that an employer-employee relationship or a substitute therefor exists for any purpose whatsoever by reason of this Agreement.

b. It is further understood and agreed by the parties hereto that Contractor, in the performance of Contractor's obligations hereunder, is subject to the control and direction of City as to the designation of tasks to be performed and the results to be accomplished under this Agreement, but not as to the means, methods, or sequence used by Contractor for accomplishing such results. To the extent that Contractor obtains permission to, and does, use City facilities, space, equipment or support services in the performance of this Agreement, this use shall be at the Contractor's sole discretion based on the Contractor's determination that such use will promote Contractor's efficiency and effectiveness. Except as may be specifically provided elsewhere in this Agreement, the City does not require that Contractor use City facilities, equipment or support services or work in City locations in the performance of this Agreement.

c. If, in the performance of this Agreement, any third persons are employed by Contractor; such persons shall be entirely and exclusively under the direction, supervision, and control of Contractor. Except as may be specifically provided elsewhere in this Agreement, all terms of employment, including hours, wages, working conditions, discipline, hiring, and discharging, or any other terms of employment or requirements of law, shall be determined by Contractor. It is further understood and

agreed that Contractor shall issue W-2 or 1099 Forms for income and employment tax purposes, for all of Contractor's assigned personnel and subcontractors.

d. The provisions of this Section 19 shall survive any explration or termination of this Agreement. Nothing in this Agreement shall be construed to create an exclusive relationship between City and Contractor. Contractor may represent, perform services for, or be employed by such additional persons or companies as Contractor sees fit.

#### 20. NOTICES

Except as otherwise specifically provided in this Agreement, any notice, submittal or communication required or permitted to be served on a party hereto, may be served by personal delivery to the person or the office of the person identified below. Service may also be made by mail, by placing first-class postage affixed thereto, and addressed as indicated below, and depositing said envelope in the United States mail to:

## <u>EXHIBIT A</u>

#### GENERAL SCOPE OF WORK

- 1. Contractor shall furnish complete maintenance service for all HVAC equipment listed herein including:
  - Bi-annual preventive maintenance, some quarterly service for specified areas.
  - Emergency call-out service (trouble-call)
- 1. This agreement shall include maintenance and repair service for all HVAC equipment listed herein bl-annually (May and November) to be performed by the contractor including but is not limited to the following:
  - Routine, recurring and usual work of preservation, protection and keeping of ALL equipment associated with the continuous functionality of the HVAC systems for its intended purposes in a safe and continually useable condition for which it has been designed, improved, constructed, altered or repaired.
  - Testing as related to the equipment including the calibration of all HVAC equipment controls, thermostats, VAV box controllers, economizers, and any other equipment associated with the HVAC systems by the contractor. Calibration shall be completed with the first 90 days of contract award.
  - All necessary chemical treatment for cooling tower(s), air conditioning, and heating systems shall be provided as part of this agreement and any cost associated therewith shall be the responsibility of the contractor. Said treatment shall be supplied and administered by a recognized company in the water chemical treatment business or the contractor, all as approved by the City.
  - Any necessary feed equipment shall be provided by the contractor and included in this agreement.
  - All necessary action shall be taken to assure minimum sealing of system.
  - All testing as related to the equipment shall be performed within accordance of two times per year, within the first 15 days of May and within the first 15 days of November, and the test results are to be forwarded to the Facilities Maintenance and Operations Coordinator, 65 Stony Circle, Santa Rosa, CA 95401.
- 2. All scheduled repairs of the HVAC equipment shall be performed during the City's normal work hours of 7:00am-5:00pm, Monday through Friday, excluding regular scheduled City holidays. Contractor must be accompanied by City staff while on City property. Contractor shall fill out electronic "work tickets" for each site on each visit denoting work performed. Contractor will receive a copy of the work ticket, as well as a copy will be forwarded to the Facilities Maintenance and Operations Coordinator prior to leaving City Property during each visit. Any additional work recommended shall be submitted to the Facilities Maintenance and Operations Coordinator on a separate electronic "quote sheet" within 24 hours from the last visit.
- 3. After award of bid and Issuance of notice to proceed, it shall be the responsibility of the contractor to make a thorough survey of the HVAC equipment designated herein. This

survey should be completed within the first 90 days of the contract. Should it be found that any equipment requires extensive or major repairs, the contractor shall submit to the Facilities Maintenance and Operations Coordinator a complete description of the repairs needed and an estimated cost for said repairs including labor and materials. The City shall be required to solicit bids for all repairs exceeding \$5,000.00. Survey can be done during the first PM visit.

- 4. Once a diagnosis has been made, any repairs exceeding \$1,000.00 will need to be submitted to the Facilities Maintenance and Operations Coordinator on the proper form (quote sheet). Any repairs under \$1,000 may be completed without the need for prior approval.
  - All quotes must be approved by the Facilities Maintenance and Operations Coordinator prior to work being performed.
- 5. The City of Santa Rosa will be responsible for all equipment repairs including labor and materials that are not covered under routine maintenance. The City reserves the right to have said repairs made and/or parts replaced by other contractors should it be for the best interest of the City. The City is required to solicit bids for all work exceeding \$5,000.00,
- 6. The City is going to require the contractor to utilize a web-based access verification system to track and report services provided. The use of such system will provide the documentation necessary to confirm that services were provided at the time invoiced. The City will determine what system will be utilized at a later date and provide contractor with access and training for use of this system.

If bidders have availability of such system already existing, please provide Information included in your bid response for review and City approval. If the system does not meet the criteria identified herein, the City may elect the contract to use the City provided system.

Such systems will include but are not limited to the following:

- o Use of RFID tags, bar codes, QR codes or other approved devices
- o Trackable hours of services through individual scans on each unit
- o Use GPS to validate the position of the devices when scanned.
- 7. Contractor is responsible for disposal of all nonoperational or surplus equipment, as well as any other substances associated with making replacement or repairs.
- 8. Contractor will respond to the COR within one-hour, either by phone, or in person, for non-emergent calls from the City.
- 9. Contractor must respond "on site" to the COR within one-hour response time for any "emergency" calls. The City will identify what is classified as emergent to the Contractor during these calls.
- 10. Contractor will be required to attend monthly meeting with Facilities COR, schedule to be agreed to by both parties.
