4.1 REVIEW OF O&M AND CIP BUDGET ALLOCATIONS

Kimberly Zunino, Deputy Director Water Administration gave an overview of cash funding and discussed allocated amounts of CIP and O&M allocations. The committee was given a report outlining the O&M and CIP allocations paid over the last 5 years.

Emma Walton, Deputy Director Engineering Resources gave a summary of the CIP Masterplan. Emma discussed three anticipated projects: Flood Wall, UV, Delta Pond. These three projects are the biggest focus and all the three projects are anticipated to be complete within the next 5 years. Emma reviewed the estimated cost of each project along with discussing CIP allocation. Increasing CIP allocation is a step in the right direction, however, capital investment still does not meet the needs of 50 projects anticipated over the next 20 years. The masterplan includes all projects identified for the next 20 years.

The committee discussed increases to the cash funded CIP and the City of Santa Rosa will be sharing the CIP Masterplan with the committee.

4.2 GESYERS UPDATE AND CONSERVATION CAMPAIGN

Joe Schwall, Deputy Director Regional Water Reuse Operations provided an update on the Kincade fire's impact to regional water reuse operations. The Kincade fire destroyed several power poles owned by Calpine and power was lost to the pump stations on the pipeline, shutting down the geysers pipeline operations. Power was restored to the pump stations after six weeks. The reclaimed water that could not be pumped to Calpine was stored in the system's storage ponds. This extra stored water increases the likelihood of discharge this winter, by February 2020 if average winter flows occur. We have communicated with the North Coast Regional Water Quality Control Board staff to apprise them of the system's status.

Claire Nordlie, Sustainability Coordinator presented the City of Santa Rosa WaterSmart Winter Campaign. The WaterSmart Winter campaign begins December 2019 through March 2020 encouraging residential customers to schedule a WaterSmart check-up, find and fix leaks and replace inefficient fixtures in an effort to reduce wastewater flow into the treatment plant. The committee has been asked to spread the message regarding the WaterSmart Winter campaign. Outreach materials can be customized for each Regional Partner.
