Subject: Comments concerning property management at Roseland Village and the appeal of the Plaza Temporal Project to the Design Review Board

Dear Ms. Meads:

The purpose of this letter is to respond to the enclosed comments submitted to the Sonoma County Counsel and The City of Santa Rosa's Planning Department regarding the Roseland Village Shopping Center and the Plaza Temporal / Mitote Food Park Project.

Background

The 7.1 acre Roseland Village Shopping Center ("Site") is owned and managed by the Sonoma County Community Development Commission ("Commission"), with the assistance of a property management firm and various other vendors who utilize the site. The Commission has entered into a Disposition and Development Agreement with Mid-Pen Housing and Urban Mix for the redevelopment of the Site. The Site has been approved by the City of Santa Rosa for redevelopment including affordable and market rate housing, a public plaza, civic building, mercado commercial building and an outdoor open-air food truck project referred to as "Plaza Temporal".

The Site is vacant for the exception of an approximately 35,000 square foot building. In 2014, five structures on the Site were demolished in anticipation of redeveloping the property. The northern portion of the site is now fenced off and not accessible, as it is the subject of an environmental cleanup effort. A small portion of the Site, which was the former site of an Albertsons Store, is decorated with colored concrete blocks and houses a memorial to Andy Lopez.

Current Use

The current use of the Site includes the 35,000 square foot building that houses a Dollar Tree store and a community center occupied by the Sonoma County Library, St. Joseph Health and other users. The Commission also issues Temporary Use Permits for outdoor events that include





the Redwood Empire Food Bank, Doctors Without Borders mobile pet clinic, and other non-profit uses. A licensed food truck has also been issued a Temporary Use Permit for the parking lot.

Emails sent to you by Mr. Robert Nellessen raise the following concerns on the Site:

- Unauthorized use of the Site
- Sanitation (public urination and defecation)
- Trash and garbage

Unauthorized Use

Concerns have been raised regarding certain uses of the Site not authorized by the Commission. When the Commission is informed that an unauthorized user is attempting to utilize the Site the Commission has options on how to respond including those as outlined below.

- Unlicensed food vendors, car washes, used car sales and others. We employ roving security with periodic visits throughout the day and night. Unauthorized users are told to leave, and when necessary reported to the Santa Rosa Police Department.
- Unauthorized car "sideshows" have also been staged on the Site. The Santa Rosa Police Department will typically respond to large gatherings that include the sideshow activity.
- On June 2nd, an event honoring what would have been Andy Lopez's 20th birthday was held on the Site. The Commission was not requested to permit this event. Reports from our tenants reported no problems with the event and protests.

Sanitation Facilities

The communications allege that after the June 2nd event, there was a large amount of excrement on the property located near the Andy Lopez Memorial. Our staff investigated on Friday June 5th and found very little waste. The Commission contacted our janitorial and cleaning company to clean up the area. The attached photographs shows the area in question.

Trash and Garbage

The Site consists of nearly six acres of open area, which does occasionally lead to trash blowing onto the Site from the street and surrounding area. We routinely sweep the parking lot and pick up trash and garbage.

Plaza Temporal

The Plaza Temporal site consists of approximately 15,000 square feet along the Sebastopol Road Frontage and will contain a fenced enclosure around the property, landscaping, seating, ADA restrooms for customers, trash and recycling containers, a trash and recycling enclosure, lighting, exiting and ADA parking, rotating food trucks and a bar located inside of a shipping container. The Plaza Temporal Project will convert a portion of the existing vacant lot to an active use that will be managed and controlled. The Plaza Temporal Project and redevelopment will substantially improve the Site and assist with alleviating the concerns raised regarding unauthorized use and trash.

The Sonoma County Community Development Commission is eager to move forward with the implementation of the Plaza Temporal Project.

Hi Bob,

I am so glad that these unfortunate times haven't dampened your excellent wit!

Don't worry about having your secretary send the documents, I will just do a quick run to the office to scan and upload them. The manager's due date for this project is Tuesday next week, so it will be easier for me to just take care of it.

The hearing is on the 6/18 DRB agenda. It will be noticed via postcard mailing to all owners and tenants within 600-feet of the project, a sign will be placed onsite within 10 days of the hearing, and a notice will be placed in the Press Democrat. I am hopeful that public participation will be as great as we saw at the ZA hearing. The applicant is the Sonoma County Community Development Commission so I do not know if the tenant who is going to lease the space (Octavio Diaz) will attend. I hope that he does and will let him know when is the meeting.

All you have to do is let me know (as you now have) that you want to do a mock meeting. Would either Friday June 5th or 12th work for you? I will reach out to the admin staff to see what time/date they are available. The admin staff essentially host the meeting and advance the visual presentation (as instructed by the presenter), mute and unmute participants etc. They will be the only person at the Chamber when the meeting is happening. The rest of us (including me) will attend the meeting remotely. We will not be visible. Our name however will show when we are speaking. At a mock meeting we will literally go through each of the steps that will happen the afternoon of the hearing. If you have a presentation please send it to me so that I can forward it to the admin team so that you are able to practice how that will work. I will be sure to have my PowerPoint available so you can see the process regardless. Note that you could join the zoom call via telephone and watch the meeting on your computer. Since we are not going to be seen, and the admin staff handles any visual presentations, you don't need a camera. If you join via the phone, there are still ways to "raise your hand" to participate, etc. and your audio would be heard when presenting. We can practice it however you would like. Dear Ms. Abelson,

Yesterday Mr. Paulsen was advised of a planned Protest/Riot to occur at Roseland today. With little informal warning (nothing from the County or City to me or Mr. Paulsen) I was able to issue only a cursory letter to the City Attorney and County Counsel. Today Mr. Paulsen advised me of the following unacceptable and intolerable conduct tolerated on the County property. There must be an immediate acknowledgement and communication of a plan to minimize or eliminate misbehavior on the County property. First, there is a large open air outdoor "bathroom" on the "Albertson's" concrete slab immediately adjacent to the Paulsen Roseland Village property. This putrid, completely unsanitary, urine and human feces strewn area was enabled when the County erected a "temporary" mural encouraging human defecation behind it on the property line.

This needs to be cleaned immediately. TODAY THE ACCESS TO THE DISEASE AND PESTILENCE VECTOR MUST BE CLOSED OFF. Obviously the stinking unsanitary condition would not be tolerated in the rest of Santa Rosa. Let us record how well the County is taking care of its property today as proof of how well it will care for its property tomorrow.

Second, The City and County know that the Albertson's slab is an attractive nuisance for regular auto side shows. Last night while the City Police were busy protecting the affluent, Roseland was abandoned. I personally called twice and "Dispatch" was "too busy" to worry about Roseland. This morning the fresh tire rubber was manifest. THE COUNTY MUST PROVIDE THE PRIVATE SECURITY PROMISED as proof that it really will care responsibly for its property.

Third, The County property has CONTINUOUSLY been used by unregulated food food vendors. THERE IS NO SANITATION, NO HAND WASHING OR PORTABLE BATHROOMS. Human excrement indiscriminately fouls the County

property. The County makes NO EFFORT WHATSOEVER to regulate the lack of social distancing or sanitation. SHAMEFUL

Mr. Paulsen is attempting to maintain a viable retail shopping center, providing goods and services to the Roseland community--despite the County and City transparent efforts to destroy his property and the community (unanimous opposition-as in every last speaker, 80% Hispanic!- futilely objected to the County/MidPen Pig Pen bar for example). Please tell me today so I can assure him that the County and City indifference will not continue.
