## RECOMMENDATION

It is recommended that the Council review the Economic Recovery Task Force list of efforts and considerations and provide direction to staff.

## **EXECUTIVE SUMMARY**

In response to the impacts of the pandemic, City Manager McGlynn formed the Santa Rosa COVID-19 Recovery Framework comprised of four task forces, one of which focuses on economic recovery. The objective of this task force is to address current issues that are within the City's purview resulting from the pandemic and related health orders while strengthening Santa Rosa's economic recovery and resiliency for the long run. Since its first meeting on April 10, 2020, the Economic Recovery Task Force agenda has been dynamic and evolving based primarily on direct and indirect input from any and all sources, and actions that address or respond to the changing nature of the health orders. As of the June 2, 2020, council briefing, there were 30 items bucketed into five categories: current projects, potential action items, resolved items, actions that were moved to another committee, or work that could be accomplished through staff level action. Subsequent to hearing the briefing, Council took action to have the list reviewed and prioritized by Council in a public setting via a study session. Since June 2<sup>nd</sup>, two new items were added to the list for consideration, though, in accordance with Council direction, the Task Force only agendized and continued to discuss and work on items that were in motion as of June 2<sup>nd</sup>. This study session will provide the Economic Recovery Task Force direction on how the full Council wants current identified actions prioritized, as well as how the task force may move forward effectively in responding to continually changing conditions and acting on new ideas and opportunities.

## <u>BACKGROUND</u>

On April 10, 2020, in order to respond quickly and effectively to the recovery needs related to the pandemic emergency orders, the City Manager created the Santa Rosa COVID-19 Recovery Framework comprised of four task forces and select County work groups. These are:

- County Level Representation Working Groups
  - Health & Emergency Management Services
  - Social Services
  - Education

Regarding the Economic Recovery Task Force, Vice Mayor Fleming and Councilmember Sawyer were assigned as Council participants along with core staff members Assistant City Manager Guhin, Economic Development Division Director Raissa de la Rosa, Acting Finance Director Alan Alton, and Chief Assistant City Attorney Jeff Berk and/or Assistant City Attorney Ashle Crocker. In addition, staff from other City departments and divisions participate depending on the agenda topic and area of expertise required including, most commonly, Planning, Engineering, Building, Public Works, Parking, Special Events/Public Art.

The objective of the Task Force is to address immediate issues and needs of the business community and local economy resulting from the pandemic and related health orders while strengthening Santa Rosa's economic recovery and resiliency for the long run. The group prioritizes actions needed to help get through the current situation yet continues to identify and act on efforts that may affect mid- and long-range needs and opportunities for business, the workforce, and the economy.

Input for prioritized agenda action and/or items to be considered within any of the five bucketed categories are culled from but are not limited to direct conversations with businesses, business and labor interest groups, requests and recommendations from councilmembers and staff, regional discussions and efforts, opportunities or actions resulting from the health orders, community suggestions, model actions from other communities, etc. The Task Force has cast a wide net to identify needs and opportunities, and to figure out how to respond quickly, effectively, equitably and openly to the uncertainty the pandemic has thrust on the global economy.

## PRIOR CITY COUNCIL REVIEW

There was no previous Council action specific to directing the Economic Recovery Task Force on prioritizing efforts, nor what and how needs/efforts/actions should be considered. Council has been provided updates by the City Manager on all task forces and work groups via written and verbal communication.

## **ANALYSIS**

At this time there are 33 items bucketed into five categories for action stemming from or analysis by the Economic Recovery Task Force: current projects, potential action items, resolved items, actions that were or moved to another committee, or work that could be accomplished through staff level action. These items are summarized as follows and are further explained in Attachment One to this report.
