RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING A THREE-YEAR EQUIPMENT STANDARDIZATION AND A BLANKET PURCHASE ORDER WITH STROMMEL INC., DBA LEHR AUTO ELECTRIC, SACRAMENTO, CALIFORNIA IN AN AMOUNT NOT TO EXCEED \$275,000 FOR THE PURCHASE OF EQUIPMENT FOR PREVIOUSLY PURCHASED 2020 FORD POLICE INTERCEPTOR SUVS

WHEREAS, the Fleet Maintenance division of City's Transportation and Public Works (TPW) Department has a need for the equipment to upfit twenty-three (23) recently purchased 2020 Police Interceptor SUVs; and

WHEREAS, Fleet worked directly with Santa Rosa Police Department staff to assemble a prototype that will fit the needs of the officers utilizing the vehicles; and

WHEREAS, the Finance and TPW Departments issued Invitation for Bid (IFB) 20-60 for the purchase of equipment to upfit the recently purchased SUVs; and

WHEREAS, bidders were required to quote firm fixed prices to supply the nineteen (19) specific pieces of equipment that are produced by three different manufacturers (Havis, Setina, and/or Whelen) used in the prototype; prices for additional equipment will be based upon a set percentage off retail price lists as noted within the bid response, attached to this resolution as Exhibit A; and

WHEREAS, Fleet Maintenance requests a three-year standardization for specified sole manufacturer on prototype parts from Havis, Setina, and/or Whelen; and

WHEREAS, Strommel Inc., dba Lehr Auto Electric, Sacramento, California, is the lowest responsive and responsible bidder.
