# **RECOMMENDATION**

It is recommended by the Transportation and Public Works Department that the Council, by resolution, approve the SB1 State of Good Repair Project List for Fiscal Year 2020-21 for preventative maintenance, and authorize the Director of Transportation and Public Works or his designee to request the City's allocated Fiscal Year 2020-21 State of Good Repair funding in the amount of \$25,473 from the California Department of Transportation.

## **EXECUTIVE SUMMARY**

State of Good Repair (SGR) funds will assist Santa Rosa CityBus in maintaining the fixed-route fleet of buses, providing efficient and reliable service to the community.

### **BACKGROUND**

- 1. The State Transit Assistance (STA) funding from the SGR account authorized under Senate Bill 1 (2017) is funded from a portion of a new Transportation Improvement Fee on vehicle registration.
- 2. The SGR program goal is to provide funding for capital assistance to rehabilitate and modernize California's existing local transit system. The City of Santa Rosa will receive an estimated \$25,473 based on the revenue allocation method; that is, the amount of revenue generated by the operator's transit system relative to other transit operators statewide.

# PRIOR CITY COUNCIL REVIEW

On May 7, 2019, the City Council, with RES-2019-047, authorized the application for FY19-20 SGR funds.

On August 21, 2018, the City Council, with RES-2018-146, authorized the application for FY18-19 SGR funds.

## ANALYSIS

- 1. Transit staff has prepared the request for funds in the amount of \$25,473 from the SGR program for FY20-21 to assist in the maintenance and repair of the fixed-route buses in the CityBus system.
- 2. To submit the request for funds, an approved resolution from the Council is required by the California Department of Transportation demonstrating local support for the application to the SGR program.

## FISCAL IMPACT

There will be no financial impact to the General Fund. These funds are included in the Transit Division budget for FY20-21.

## **ENVIRONMENTAL IMPACT**

This action is categorically exempt from the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15301, Existing Facilities. Specifically, the project consists of the repair, maintenance and minor alteration of existing public facilities involving no expansion of use.
