# WHY CHILD CARE MATTERS TO BUSINESS

RESEARCH SHOWS THAT BABIES FORM OVER



of the brain connections that determine how they talk, think, and grow by the time they are 5 years old. ON AVERAGE, HALF OF PARENTS MISS

THE NUMBER OF CHILD CARE HOMES HAS DECLINED BY 22% SINCE 2012, A LOSS OF

266 PROVIDERS AS A RESULT OF THE 2017 WILDFIRES, 15 LICENSED CHILD CARE CENTERS WERE DESTROYED, DISPLACING

444 CHILDREN





#### **Available Facilities Pre-COVID**




#### **Available Facilities - Current**

# Childcare Support Pilot Program



### Goals:

- Stabilize business (short-term)
- Expand capacity (mid-term)
- Enable new and rehab existing facilities (mid- to long-term)

### **Initial Investment Requested:**

• \$600,000 CARES Act funds

### **Partner Organizations:**

- First 5 Sonoma County
- Community Child Care Council of Sonoma County (4Cs)
- Community Foundation of Sonoma County



# Sonoma County Child Care Resiliency Fund



### STABILIZING BUSINESSES

### Overview:

- \$500,000 City funds for one-time grants to licensed and license-exempt childcare providers
- Can be used for broad range of needs

### Purpose:

 Provide direct support to local childcare businesses in support of economic recovery and stability by ensuring families can return to work



# Use of Grant Funds



### Costs that most support business sustainability, including:

- Costs to maintain a safe environment
- Operating costs
- Cost of equipment and furniture to accommodate distance learning

### **Priority Weighting:**

- Provide childcare services to the most vulnerable residents
- Demonstrate fiscal sustainability
- Participated in Quality Counts Sonoma County prior to 3/1/2020



# Program Eligibility



- A. Children in operator's care are between birth to 12 years old
- B. Operator provides care in:
  - A private childcare center
  - A large or small family childcare home
  - A license-exempt setting (e.g. parent cooperative care)
- C. Operated as a childcare business prior to 3/17/2020
- D. Currently open, or if closed due to COVID, have feasible plan to re-open by 1/15/2021
- E. Non-profit agency, private business, or governmental agency



# Child Care Initiative Project



### **EXPANDING CAPACITY**

### Overview:

• \$100,000 City funds to expand the Child Care Initiative Program to build the supply of infant/toddler care

### **Program Elements:**

- Teacher training and licensing assistance
- Business startup guidance and assistance
- Disaster planning training



# Desired Outcomes



- 50% of prospective providers enrolled in CCIP receive licenses
  - Measure: # of providers who receive childcare license
- Available infant and toddler care capacity increases by 2%
  - Measure: comparison of baseline care capacity

### **ENABLE NEW FACILITIES | REHAB EXISTING FACILITIES**

### Overview:

- Goal of \$1,400,000 for additional and expanded programming, including
  - Subsidizing childcare center integration into new development projects
  - Rehabilitating existing sites for childcare uses

### **Program Elements – draft priorities:**

- Integrated into mid- to high-density development
- Located within a transit priority area, priority development area, specific plan area
- Council approval required for new program elements and expenditures



### Recommendation

It is recommended by the Economic Recovery Task Force that the Council, by resolution,

- allocate \$2,000,000 to the Childcare Support Pilot Program from General Fund reserves made available by reimbursements of COVID-19 expenditures from CARES Act funding, and
- approve funding agreements totaling \$600,000 with First 5 Sonoma County and Community Child Care Council (4Cs) Sonoma County for childcare related services.
