SIXTH AMENDMENT TO GENERAL SERVICES AGREEMENT NUMBER F001318 WITH FISHMAN SUPPLY COMPANY

This Sixth Amendment to Agreement number F001318, dated December 27, 2016 ("Agreement") is made as of this 5th day of January, 2021, by and between the City of Santa Rosa, a municipal corporation ("City"), and Fishman Supply Company, Petaluma, CA, a California Corporation, ("Contractor").

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide janitorial supplies. The First Amendment added contract items and increased compensation. The Second Amendment extended the term of the Agreement for one year, increased compensation and revised the cost for two contract items. The Third Amendment changed product brand, revised the cost of one item and increased compensation. The Fourth Amendment extended the Agreement and increased compensation. The Fifth Amendment extended the Agreement and increased compensation.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term of the Agreement and increasing the compensation.

<u>AMENDMENT</u>

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional year.

2. SCOPE OF SERVICES

Exhibit A-5 to the Agreement is replaced by Exhibit A-6 to this Amendment.

COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$80,000 to read as follows:

Page 1 of 3

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$381,645.71. The Chief Financial Officer is authorized to pay all proper claims from various department charge numbers."

4. COUNTERPARTS AND ELECTRONIC SIGNATURES

Section 22 (Counterparts and Electronic Signatures) is added to the Agreement after Section 21 (Authority; Signatures Required for Corporations) as follows:

"Section 22. COUNTERPARTS AND ELECTRONIC SIGNATURES

This Agreement and future documents relating thereto may be executed in two or more counterparts, each of which will be deemed an original and all of which together constitute one Agreement. Counterparts and/or signatures delivered by facsimile, pdf or City-approved electronic means have the same force and effect as the use of a manual signature. Both City and Contractor wish to permit this Agreement and future documents relating thereto to be electronically signed in accordance with applicable federal and California law. Either Party to this Agreement may revoke its permission to use electronic signatures at any time for future documents by providing notice pursuant to the Agreement. The Parties agree that electronic signatures, by their respective signatories are intended to authenticate such signatures and to give rise to a valid, enforceable, and fully effective Agreement. The City reserves the right to reject any digital signature that cannot be positively verified by the City as an authentic electronic signature."

All other terms of the Agreement shall remain in full force and effect.
