- 1. At least one year of graduate study in architectural preservation, American architectural history, preservation planning, or closely related field; or
- 2. At least one year of full-time professional experience on historic preservation projects. Such graduate study or experience shall include detailed investigations of historic structures, preparation

of historic structures research reports, and preparation of plans and specifications for preservation projects.

1. Substantial contribution through research and publication to the body of scholarly knowledge in the field of history.
