Dear Mayor Rogers and Santa Rosa City Council Members,

I come to you hoping my voice and others are heard. When my husband took his Oath as an Officer, we as a family knew what the job was going to require. The only one I'll list right now for the sake of time is the obvious, working many hours including mandatory overtime (being held over on a call, critical incidents, and unexpected call outs when they're off duty). We missed our honeymoon, my husband missed quite a few of both of our son's birthdays, our sons playing sports, holidays (just for this particular 2020/2021 rotation, he missed all of them), he wasn't able to be with me when my father almost died (3 times) from complications of heart surgery, he wasn't able to stay with me or help me once I got home from having emergency surgery, he missed his only sibling's wedding, family reunions, and so much more. But we never hesitated or regretted him taking this job. It was what he always wanted to do and it was what I wanted to support him in doing though it almost cost us our marriage because of what "the job" was doing to our relationship. "The job" was keeping us apart and neither of us had a say in it unless he quit, which for both of us, was not an option. He loves working with the community he was born and raised in and quite frankly, he's darn good at it.

It's heartbreaking to see you, Santa Rosa's Mayor and City Council Members, time and time again not support our men and women at the Santa Rosa Police Department. Many in the community and friends and family members of these Officers have had enough though. The icing on the cake was your ridiculous mandate of taking down the Thin Blue Line banner given as a gift to the Police Officers at SRPD from our own community members, people both you and our Officers serve. To the donors of that banner, this Police Wife thanks you for thinking of our Officers and supporting them.

The Thin Blue Line flag represents Officers like Officer Natalie Corona who was murdered on duty while helping a citizen. Let's not forget our own Law Enforcement from Sonoma County who died in the line of duty. The Thin Blue Line represents Deputy Frank V. Trejo, Detective Marylou Armer, and our friend and co-worker "Mac" who completed suicide which sadly, is not uncommon for Officers especially when they've been through the types of calls they respond to and investigate day after day and year after year. I encourage you to educate yourself on the number of suicides and line of duty deaths per year for Police Officers. The Thin Blue Line is symbolic to Officers and their families both (as we say) blood and blue. It represents the love and support we have for those who burden the badge and the families who stand with them. It represents the Fallen and how much we appreciate them, their service, and the ultimate sacrifice they made. It reminds us tomorrow isn't promised. I hug my husband before every shift wondering if it's the last time I'll see him alive.

I asked my sons to write something to you as well. I said to both of them "Tell the Mayor and City Council what the Thin Blue Line means to you and what does your daddy mean to you?"

7 years old: It's for all of the Officers who died in the line of duty. What Daddy means to me? He's a good police officer and I love him.

11 years old: The Thin Blue Line is very important to me because it reminds me of the good in the world fighting evil and to also respect the people who have died in the line of duty. To be the son of a police officer is a little scary because I don't want him to get hurt or die. The police are superheroes. Our police officers are misunderstood as bad people but they're not. They leave their families everyday to help others and sometimes that makes me sad because my dad can't always be with me. Please let them keep their Thin Blue Line banner.

To Members of the Santa Rosa City Council:

First, I ask that you do not disregard my voice simply because I am a retired police officer, as I am also a long-time member of this community. I proudly served Santa Rosa Police for twenty-five years, and prior to that worked at other police agencies. I can say out of the agencies I worked for, SRPD is the most professional and dedicated. All of the employees of the police department are not just employees, they are community members who live here, work here, volunteer here and raise children here. They are a diverse group of human beings who impact their community in many ways in addition to sacrificing to be essential workers who hold that "blue line" between the public and those who would cause harm to them. I believe that most of THEIR community supports them and empathizes with the difficulties of their job.

Community members gifted a banner of support for their police, and city officials ordered Chief Navarro to remove it. *The community members who gave that banner have a voice that deserves to be heard.* They represent the majority of Santa Rosa residents who acknowledge that police work is a difficult job. These community members saw the courageous acts of our police officers during the Tubbs fires, where officers saved lives despite shock, fear, and loss of their own homes. These community members cried with our police employees at the death of Detective Mary Lou Armer and left flowers at the police department in support. Yet, those employees, her dear friends and co-workers, kept showing up to work. Despite being painted with the same brush as the few flawed officers nationwide, officers showed up to face protesters, vandals, and those who threatened to do them harm in order to protect the residents of this city.

The knee-jerk reaction to this banner and social media post is not what I expect from my elected officials or the City Manager. Just as police officers are expected to look at all sides of an issue and make a careful and informed decisions (even under split second, life-or-death circumstances) those charged with running our city should take a more global approach and consider all stakeholders.

Some fringe groups have hijacked other symbols, such as the American flag. Should we take that down as well? Gang members have used the word "Santa Rosa" in their title, or "707" area code. Do we simply acquiesce and stop using those terms? I believe those in authority (members of council and city manager) are dismissing the majority of Santa Rosa residents and voters who support their police and believe the thin blue line is a symbol of those willing to stand between danger and the public.

I also feel compelled to address the social media remarks made by council member Alvarez. His lack of professionalism and cavalier public criticism of SRPD is contrary to the values of this city. Police employees DO NOT have the option of expressing themselves in this rude and ignorant manner as they would face discipline. I hope the rest of the council understands how detrimental it is to the relationship between the community, the police, and the council to behave in this disrespectful manner.

The hiring standards of SRPD have always been stringent and I believe the personnel ultimately hired are some of the best you can find. The morale of your police department is suffering due to the fires, pandemic, loss of an officer, public perception and the behavior of this city council.

This will be a huge issue in recruitment and retention of the remarkable quality of officers you have. I suggest instead of wasting time micromanaging the Chief and publicly insulting the agency, the Council should show some support and collaboration with your police department to enhance public safety and improve the relationship with the community.

To Councilman Schwedhelm and the entire Santa Rosa City Council,

I am a lifelong resident of Sonoma County. I spent 18 years as a volunteer fire fighter and 26 years as a full-time paid fire captain specializing in vegetation management. I have dozens of friends serving in both law-enforcement and the fire service as well.

I am deeply concerned with councilman Alverez and his friend's Facebook conversation about how they consider the Santa Rosa Police department and its members to be "trash". This statement coming on the heels of a knee-jerk reaction order from the Santa Rosa city Council directing the Santa Rosa police chief to remove a "thin blue line flag" banner given to them by gracious and very thoughtful residents of Santa Rosa.

Your actions in ordering the removal of the gifted banner to the Santa Rosa police department is disrespectful, disgusting and supports the false narrative that Law Enforcemt officers are racist! A very small handful of people subscribing to the far left view that officers are racist, complained about this amazing gift of support and honor given to the Santa Rosa Police Department and its members in the form of a banner with the "thin blue line" symbol on it from a fellow community member. After you received these handful of negative comments about the thin blue line flag gift your decision was to order it's removal and thus essentially siding with their false idea that this represents racism when it clearly does not.

Most of us are Americans that live in the middle of most ideas and do not subscribe to either far right or far left notions. We take an honest look at everything and don't immediately jump to the conclusion that some thing is bad, racist or otherwise. But in this day in age it seems as though the fringe left gets to dictate what everything means; what is racist; what needs to be torn down; what needs to be removed and on and on.

For a moment let's take a side trip down memory lane. The last time that an African-American was shot by the police department was over a decade ago and under the circumstances was a completely justified shooting. This homicide suspect decided to escalate the situation to a point where SWAT had no choice but to return fire as he was not going to prison for murder and was not going to be caught alive.

In 2017 one of the most historic and at the time most deadliest, destructive wildfires swept through parts of the city of Santa Rosa. Well the community members of Santa Rosa were fast asleep in their beds not only the fire department but specifically the police department ran into the fray with no specific fire safety training nor fire safety gear in an effort to save human lives. They worked 14 to 16 hour days day after day after day for weeks on end making sure that the public and community was safe from the threat of wildfire and the aftermath left in its wake. Some of these local law-enforcement officers lost their homes while they were out protecting the community. They view the community in which they work as part of their family. The Santa Rosa city police officers heroic actions saved hundreds of lives and afterward kept the evacuated areas safe from looters and thieves. Some of these officers to this day are suffering silently with the post traumatic stress that came with dealing with this calamity and did so with little to no accolades from the city of Santa Rosa Council. But the tail of their heroic and day-to-day actions doesn't stop there.

Since the Tubbs Fire of 2017 the have had to answer the call to action against fast moving deadly blazes again. Most recently was the glass fire that yet again swept into town and threaten the lives of all of those in its path. Only this time the glass Wildfire took a game at Santa Rosa's most vulnerable community, the community of Oakmont. Once again the Santa Rosa police officers answered the call in the middle of the night and ran Head on into danger in order to save lives. Now some of you might say "well that's their job and they get paid to do it". I say to that "yes you're right it is their job and they do get paid but they don't often get shown the gratitude or recognition deserved for such heroic acts of courage while executing their duties".

Our humble law enforcement officers experience some of the most awful and terrifying human conditions anyone

could ever imagine. Unless you were in the business you would have no idea about what these officers have to see and deal with on their own each and every day they serve.

Our law enforcement officers have to respond to murders, burglaries, dead bodies, car wrecks, medical calls, calls in which victims bodies have been torn apart or squashed into unrecognizable pieces, rape, child molestation, spousal abuse and even a simple welfare check that turns into finding an elderly person who has been dead in their house for days. When officers, EMS and firefighters contend with those type of scenes there is a mental scar burns into their minds. The often putrid and vile smell of a decomposing body that permeates into our first responder and lawn Forssman's uniforms. These calls for service are never heard about in the newspaper. Councilmembers never have to see or smell or deal with the mental anguish associated with properly dealing with these incidents.

Our police officers, on a daily basis, are consistently having to walk into a completely foreign and unknown situation in which the very breath from their chest may be removed by someone in a split second. Yet day after day our heroic and courageous police officers donn that uniform and badge while suppressing the horrific memories of atrocities and mind scarring incidents that they have had to respond to and do so with the "thinnest" number of officers on the force compared with the population they serve. Nobody is there to help them, certainly not the likes of a group of political cowards safe in their homes, but rather each other and their families.

The United States flag is a symbol comprised of stars representing the states and the stripes representing the original colonies. It represents freedom, liberty, democracy and so much more. Some malcontent who has an axe to grind on a political issue can claim all sorts of things about the symbology of our United States flag and while some of those incidents may have happened, that is not what the United States flag represents and you all know that as well otherwise the City of Santa Rosa would order the removal of all US flags across the city.

As I've explained to you above the thin blue line is a symbol for law-enforcement officers all across this great nation. It's symbolizes the very nature of how small the ratio is of law enforcement officers to the number of citizens under its protection. It is comprised of officers and their loved ones who all live this job together and lean on each other for guidance, support and counsel.

The thin blue line does not represent racism. It's edicts do not advocate the beating, mistreatment or shooting of anyone and certainly not persons of color. We are not Nazi's. We are not racists! We are not PIGS. We are not Bastards! I say we because it represents Law Enforcement and their families; that it takes a family structure of support to survive the daily job and the scars the service of that job burns on their souls!

Our Law Enforcement Officers have been wrongly accused of racism and brutality. They have been called the worst imaginable things possible. Their headquarters spray painted with nasty names, the threat of violence and Old Glory ripped down and trampled while they had to sit back and take it. I suppose that's their job.

Council Members, it is not your job to bestow credibility on an accusation of racism because of an ignorant political activist saying something is racist! By its very nature, an ignorant comment or opinion has no standing in fact. The far left activists have no understanding of who our Law Enforcement Officers are nor what the meaning of the thin blue line actually is. I am both a mother and wife of a police officer. My husband has served over 30+ years as a police officer. My son has been on the force for over 2 years. Over the past year, I have not been able to sleep at night worrying about the safety of my law enforcement family. My husband and son are the types of police officers that EVERY force would be proud to have, but sadly the press has created a false narrative that has made the badge they wear a target on their chest. My son was recently recognized by the police department he works for after saving the life of a gang member that was shot in a gang related shooting. My son is white. The gang member is black. Normally there would be no need to mention the race of either my son nor the victim. However, the press and the BLM movement have created this narrative that all Cops are racists. Sadly, the people that already hated Cops have bought into this false narrative that the press has created and the lives of police officers are even more at risk than ever. My son worked the front lines of the riots in Sacramento. I understand you may soon be voting on the adoption of a Small Cell Policy to control the placement of Wireless Transmission Facilities in Santa Rosa. I ask that you keep the following requirements in mind that characterize the best policies. For the most comprehensive list, please go to:

- a) 1500 to 500 foot Setbacks.
- b) Maintain requirements for least intrusive methods.
- c) Specify Location (prohibited, disfavored, or favored).
- d) Require proof of significant gap in coverage, that has to be proven in a specific way
- e) Require notification of property owners within 500 feet (or more) of a proposed installation, notification must be done with a certified letter sent by the city of Santa Rosa- not by the Telecom industry.
- f) Require insurance coverage (in order to protect the city from liability) without a pollution exclusion.
- g) Require regular radiofrequency testing and monitoring by independent experts.
- h) Include Aesthetic requirements.
- i) Allow no multi-year agreements beyond 5 years (Tech is progressing quickly and regulations may change at the federal level, so flexibility is needed.)
