RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE EIGHT AMENDMENT TO GENERAL SERVICES AGREEMENT NUMBER F000913 WITH DAY MANAGEMENT CORPORATION (DBA) DAY WIRELESS SYSTEMS FOR MAINTENANCE, REPAIR AND INSPECTION SERVICES FOR EXISTING COMMUNICATIONS EQUIPMENT

WHEREAS, on June 2, 2015, the First Amendment added Federal Transit Clauses was approved by the Purchasing Agent; and

WHEREAS, on April 19, 2017, the Second Amendment to extend one-year with no increase to unit price and increase compensation in the amount of \$100,000 was approved by the City Manager; and

WHEREAS, on April 17, 2018, the Third Amendment to extend one-year with no increase to unit price and increase compensation in the amount of \$100,000 was approved by the City Council; and

WHEREAS, on April 4, 2019, the Fourth Amendment to extend one-year with no increase to unit price and increase compensation in the amount of \$100,000 was approved by the City Manager; and

WHEREAS, on December 3, 2019, the Fifth Amendment to increase compensation in the amount of \$40,000 for the term ending April 20, 2020, was approved by the City Council; and

WHEREAS, on April 28, 2020, the Sixth Amendment to extend the Agreement one-year and increase compensation in the amount of \$125,000 was approved by the City Council; and

WHEREAS, on December 11, 2020, the Seventh Amendment to increase compensation in the amount of \$40,000 was approved by the Purchasing Agent; and
