<p><b>CULTURAL RESOURCES</b>  <u>CR-1: Archaeological Resource Protection</u>                      At each site, if archaeological materials are accidentally encountered, the City shall halt ground-disturbing work in the vicinity of the find. Work near such finds shall not be resumed until a qualified professional has evaluated the materials and offered recommendations for further action. Recovered artifacts shall be disposed of in consultation with affiliated Native Americans. If human remains are encountered, work shall be halted in the immediate vicinity of the find and the Sonoma County Sheriff/Coroner must be notified. If the remains are found to be of Native American origin, the Native American Heritage Commission must be notified within 24 hours of the identification.
