# THIRD AMENDMENT TO GENERAL SERVICES AGREEMENT NUMBER F001647 WITH ADT COMMERCIAL LLC

This Third Ar	mendment to A	("Agreement number F001647, dated May 22, 2018 ("Agreement")
is made as of this	day of	, 2021, by and between the City of Santa Rosa, a municipal
corporation ("City"),	and ADT Com	nmercial LLC ("Contractor").

#### **RECITALS**

- A. City and Contractor entered into the Agreement for Contractor to provide fire suppression systems inspections as previously amended.
- B. City and Contractor now desire to amend the Agreement for the purpose of extending the term one year with no increase in unit cost, adding service locations, and adding compensation.

#### **AMENDMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:

1. BILLABLE RATE, PAYMENT TO CONTRACTOR

Exhibits B, B-1, and B-2 to the Agreement are replaced by Exhibit B-3 to this Amendment, and Section 5(a) of the Agreement is amended to read as follows:

- "a. Billable rates. Contractor shall be paid for the performance of service as set forth in Exhibit B-3"
- 2. TERM, SUSPENSION, TERMINATION

Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional one year.

COMPENSATION

Section 4 of the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$125,000 to read as follows:

"The total of all fees paid to Contractor for the satisfactory performance and completion of all services set forth in the Agreement shall not exceed the total sum of \$518,144. The Chief Financial Officer is authorized to pay all proper claims from various Charge Numbers."

All other terms of the Agreement shall remain in full force and effect.
