

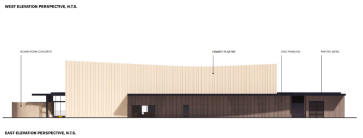
NOTICE OF PUBLIC HEARING

PROJECT NAME - Sonoma Academy Performing Arts Center

PROJECT ADDRESS - 2500 Farmers Lane, Santa Rosa, CA 95404

PROJECT DESCRIPTION - Modification to a previously approved 17,984 square-foot visual and performing arts building located at 2500 farmers lane as part of the Sonoma Academy Campus. The previous project was approved on April 21, 2016, by the Design Devew Board. The modification includes a new 18,187 square-foot building located at the same approximate location, with an updated architectural design. The project is within the scope of the 2005 Mitigated Negative Declaration and no additional environmental review is required in accordance with CEQA Guidelines Section 15162.
