7.1 CONCEPT DESIGN REVIEW - MEADOWOOD RANCH - 2853 & 2875 DUTTON MEADOW - FILE NO. DR21-018

BACKGROUND: Concept Design review for a future project to construct 90 single-family attached dwellings with accessory dwelling units and shared community recreation center.

PRESENTER: Susie Murray, Senior Planner

Marie Stewart - Expressed concerns about traffic, water, and sewer impacts; asked that current, long-term homeowners be taken into consideration, as the project has grown from 76 units to 90, then 138 units.

Senior Planner Susie Murray gave the staff presentation.

The Applicant Team gave a presentation.

BOARD COMMENTS

Consider breaking up cottage and farmhouse, moving monolith to the center.

Landscape and thoroughness of packet and design are appreciated. Project brings diversity to the use of space, with up-and-down rhythms and nods to history. Appreciates that a lot of trees and a lot of variety of trees is proposed. Brings human scale and softens the structure. Consider trees outside of the standard for a natural aspect, from previous uses of site, and wetlands. Add Oak species. Think more creatively with the plant palette, to make it

beautiful and unique. The rec center is a good amenity; bring in more family amenities for a community feel. Consider a play structure by the rec center or by Raindance Way. Consider a small sport court and barbeque area for families. Think about diversity of uses and spaces. Accessory dwelling unit additions are appreciated.

The project meets neigh design goals for Southwest Santa Rosa, especially for infill projects. Well designed for easy entry/exit to neighborhood, and is an attractive. Concurs regarding the need for play structures and family amenities.

Break down the large wall with simple detailing, using thoughtfulness around pattern and a break in materials to break up two story siding. The scale and shape of the windows is appreciated; avoid strange angles and corners.

The variety in the project in appreciated. The Rec building is appreciated. The stove-pipe effect of 2-story next to one-story can be simply resolved. Likes window patterning. The parking material is appreciated.

The project fits a definite housing need for single family rentals.
