# **RECOMMENDATION**

The City Manager and Finance Department recommend that the City Council hold a Study Session intended to provide City Council the opportunity to receive information, and to ask questions related to the City's overall financial stability and the proposed Fiscal Year (FY), 2021-22 Operations and Maintenance Budget and the Capital Improvement Program budget. No action is required.

#### EXECUTIVE SUMMARY

In the Study Session, staff will present City Council with an overview of the funding requests for FY 2021-22, as well as perspectives as to overall funding considerations. The Study Session is held in advance of the Budget Hearings in June to provide the opportunity for City Council to ask questions, provide direction, and gain a full understanding of the budget and resulting financial implications for the City ahead of formal budget adoption in June.

## **BACKGROUND**

The City's budget process began in January. The City held a public hearing on budget priorities on February 9, 2021, to solicit community input for proposed considerations. This was followed with City Council goal-setting meetings February 17-19. City departments completed entry of their proposed budgets and those submissions have been reviewed by budget staff. A presentation of the City's General Fund Long Range Forecast, including prospective revenue forecasts and resulting implications for reserves also followed on April 6, 2021.
