Thank you for the City's continuing support of the Southeast Greenway project, which will include a new City park of 29 acres, over two miles of walking and biking trails, an 18-acre addition to Spring Lake Regional Park, and almost 10 acres zoned for housing development. The Southeast Greenway Partnership has reached a critical milestone and we respectfully request your help for the Partnership's progress to continue.

Since the City approved a General Plan amendment, zone change and EIR for this two-mile long corridor from Farmers Lane to Spring Lake Park, City staff, the Sonoma Land Trust, Sonoma Water and other Greenway partners have been working together on the activities needed to acquire the land from Caltrans. These activities have included obtaining deeds, leases and other information from Caltrans, preparing detailed parcel maps, assessing property values, and reviewing purchase agreement terms.

Additional City staff time will continue to be needed for the completion of the items listed above as well as the total acquisition process. In the coming months, property appraisals will be completed, agreement terms will be negotiated, and a purchase agreement will be approved by both Caltrans and the City. Therefore, we respectfully request that the FY 2021-22 Operating Budget provide sufficient funds for these activities by the Real Estate Division, City Attorney and other City staff and for the costs of property appraisals and other acquisition work.

Caltrans wants to sell the whole 57-acre property to the City in one transaction, including both the 9.7 acres zoned for development and the 47 acres planned for City and County parks. We have secured the grants and donations to acquire the parkland, but no funding has yet been determined for the purchase of the developable parcels.

We are therefore also requesting that the Council consider using some of the PG&E settlement or other funds to help purchase from Caltrans the 9.7 acres of the Southeast Greenway property, which is zoned for 244 housing units at medium-high and medium densities. The subsequent sale and transfer of this land from the City to housing developers will give the Council the ability to control the per-unit land costs and help new affordable housing to be built, responding to the City's adopted housing goals and the need to replace the many housing units lost in the fires.

The Unsheltlered and Transitional Housing

I appreciate the extent to which Santa Rosa is investing in permanent housing for its unsheltered residents. But until permanent housing is fully available for the estimated 300 individuals currently unhoused in Santa Rosa, it is imperative that the City Council address the need for transitional housing. A Sam Jones Annex, for example, may serve some of those individuals, but shelters remain a stop-gap solution, one often rejected by unhoused individuals because of the limits placed on personal freedom and on personal belongings. There is also the problem of the 6-month time limit for people sheltering at Sam Jones.

Please recognize the very real need for transitional housing solutions that accommodate personal freedom and privacy, that foster self-respect, and that are responsive to the time-consuming processes of 1) building/securing permanent affordable housing for all who need it, 2) rehabilitating the mentally ill and addicted individuals who represent the majority of Santa Rosa's unhoused people. The proposed \$1,100,000 Mental Health Response Team Pilot Program is a commendable response to the latter problem.

Of equal importance is a commitment to provide transitional housing that is secure for the time frame needed before permanent housing is available. There are multiple tiny-house projects across the country that address the transitional housing need. Non-profit organizations in Sonoma County are developing proposals and structures that target this need as well. Examples include the Sonoma Applied Village Services Village Proposal (tinyvillages@sonomavillages.org) and structures being designed and implemented by Homes 4 the Homeless (alex@homes4thehomeless.org). Both offer significantly lower cost solutions than market rates allow.

Please allocate the funding needed to provide Santa Rosa's unsheltered residents with transitional housing villages that provide cooking, dining, bath and toilet facilities, heating, light, and waste disposal. An added benefit of these villages is the opportunity to deliver ongoing health services.

To Whom It May Concern,

It has come to my attention that the council will be discussing the "First 5 Million for the First 5 Years" American Rescue Plan Local Coronavirus Recovery Funds request, including a one-million dollars in payment to child care providers that have worked directly with children during the pandemic.

I would like to advocate for these funds to reach teachers directly through stipends. The pandemic has been a very stressful time for all, especially for frontline essential workers. 4Cs continued to support families during the months that our centers were closed. Teachers called families each week during this time to provide concrete support, community resource information (food, housing, clothes, etc.) and also sent classroom materials home (art supplies, calm down kit, etc.). Teachers continued to provide all this support during a time that they were also under stress (their own children were distance learning, spouses lost employment, not being able to see loved ones, mental health struggles in a time of uncertainty).

When our centers opened again in July, there was a great amount of planning and preparation to ensure everyone's safety, and the least amount of stress on the children as possible. However, we were all very scared and nervous. We knew that our work with children is very close; children need hugs and human connection, they need us to speak with them closely down at their level. We knew that if, for example, a child had a potty accident, they would need our help and we would not be socially distanced to provide that help. The children needed a sense of normalcy, and love and care, and we knew we needed to be prepared to provide that. We have taken as many steps as possible to teach about face masks and social distancing, but we have definitely been at high risk working in a capacity that does not always allow for social distancing. When we care for a child, we are not only exposing ourselves to that child, but also to everyone in that child's household and social bubble.

Teachers have risked their health to provide excellent care to children experiencing trauma, all while the teachers are experiencing the same trauma along with them. Some occupations allowed for hazard pay, but unfortunately teachers did not receive any hazard pay. 4Cs as an agency has supported us through job security and emergency sick leave, but State funds can be restricting and they could only provide so much. I believe the teachers deserve more for all this time that they have dedicated to the families we serve while risking their own health and the health of their families.

I truly appreciate you all taking this into consideration when making your decision for allocating these funds.

Under international law, even convicted murderers must be provided a sheltered, secure cell, food, water, and hygiene facilities.

Under U.N. rules for humanitarian response to refugees of war, famine, or natural disaster, all refugees are to be provided with at least:

- a secure site,
- tent,
- food.
- · water, and
- cooking and hygiene facilities.

Every city and county in the U.S, including Santa Rosa, should have a policy requiring the same here for all unhoused people. Every person must be provided a safe, and reasonable accommodation alternative to living on the street. Non-congregate shelters are best for this purpose.

The emphasis should be on separate, private, non-congregate shelter rooms or tents, for

- safety,
- dignity,
- privacy,
- privacy and autonomy at one's bed or in one's room to take care of one's health, and
- to prevent enormously costly, devastating kickouts of sheltered people.

(Congregate shelters result in staff and residents being in everybody else's private business, down to the manner of cutting one's toenails; resulting in a greater number of costly, wasteful, devastating kickouts.)

Regarding "sweeps," please bear in mind:

- The police actions to evict homeless campers from their sites are weekly now. They do not help homeless people. Every camp site eviction adds to the trauma of people on the street.
- Evictions interfere with campers making progress toward getting housed.
- Evicted campers must spend days or weeks finding a new location, new tent, bedding, supplies, toilet options, access to food and water, etc. All while on foot. Only to be evicted again.
- This is a terrible abuse of penniless people.
- It increases the likelihood of criminal activities and sexual exploitation to pay for their necessities.

We need solutions that keep people safe and give them a legal place to sleep.

- The money we spend on these evictions would better fund safe parking and safe camping sites.
- Homeless people are our neighbors. To ignore them and torture them with camping evictions is inhumane.

Please <u>urgently plan, with people with lived experience of homelessness</u>, a safe parking and camping pilot site in every district, NOW!

Please contact me to participate in this planning. I have many recommendations to significantly reduce costs and lengths of homelessness through better physical and system design of homeless shelters and services.

I have been a preschool teacher, educated and employed in Sonoma County for 15 years, and without a doubt this year was the hardest, and the most rewarding. After discussing with my family first, I chose to go back to work wearing gloves, an apron, and a mask to protect myself, my family, and the children in my care. The fear of the unknown weighed heavy on my shoulders, never knowing if my precautions would be frightening to the innocent eyes of 2 to 5 year olds. But I knew that being here could be enough. Throughout this past school year I have endured closures due to fears of illness, sheltering in my home even when restrictions were lifted so as to keep my preschool open and the children and families safe, all without knowing if I was making the best decision for myself and my family. My school, Hidden Valley Community Preschool, opened to just 12 families, giving children a space away from the fear society set in, and giving parents peace of my mind. This was not without cost. As adults we took on the worries of children, yet witnessed the anxiety rise in some.

The close knit community that came together to be at this school is one I will never forget, that during tragedy around us we banded together to create a safe space for growing minds. I hold a positive memory of this within my heart, but I will also remember the risk I took as an educator, knowing it is what the children needed.

First, I'd like to acknowledge and extend my deep gratitude for the Council's commitment of \$2 million of CARES Act funding earlier in the pandemic to mitigating the crisis in our child care sector. This was a down payment on the future that continues to stabilize and make a substantial impact on an essential part of our local economic infrastructure and has helped dozens of child care providers to stay afloat, as well as begin to rebuild our supply of family child care so that our community can truly re-open.

Today, as the Council studies the needs and potential opportunities during your Budget Study Session, I urge you to consider the joint request of leaders across the cradle to career continuum for the "First 5 Million for the First 5 Years". This <u>combined request</u> to the cities and towns across our county and the Board of Supervisors is to dedicate <u>one-time funds</u>, a small, but impactful percentage of the American Rescue Plan Local Coronavirus Recovery funding, to address the impacts of the COVID-19 pandemic on the youngest residents of Santa Rosa and their parents.

Many Santa Rosa families are in crisis. By making a one-time investment to bolster safety net navigation and community based resources for early childhood and maternal mental health, the City will help strengthen families, prevent child abuse and neglect, and promote positive interactions within families and caregivers to help children develop their potential and equitably recover from the impacts of the pandemic.

Our community's families have been through so much, with recurring disasters since 2017 and the isolation, fear and emotional and financial stress of the pandemic. Trauma and toxic stress in a young child's life can impact how that child develops and functions. It is critical to invest now in positive early childhood mental health and to stabilize our network of community-based, child-serving organizations to help ensure the success of children and families as we emerge from this crisis.

The need to continue to support the child care sector is more critical now than ever. In spite of local, state and federal efforts, our community HAS lost a significant number of child care slots, which as you know, will cripple parents' ability to return to work and will slow down our local economic recovery. Many frontline child care providers worked throughout the pandemic, putting their own health and lives on the line in order to provide safe and nurturing care for children so parents were able to work. It is


critical that we fortify our struggling child care workforce so that we can ensure that our community's children have a strong foundation - this is key in the development of our future workforce.

Sonoma County Families are in Crisis. The COVID-19 pandemic has put a huge strain on families with young children due to health concerns, stress, isolation and income loss. In the past year, many families have been pushed into poverty, particularly Latinx families who have suffered disproportionately greater economic and health impacts¹. Most concerning are the proven long-term impacts of childhood poverty and adversity on physical and mental health, brain development, and school readiness and the risk that shorter-term pandemic impacts will deepen racial disparities in access to affordable housing, healthcare, and education.²

As parents return to work and children to child care and school, experts predict trauma and toxic stress to surface. Data from the *Family, Youth and Children Division* of the Sonoma County Human Services Department reflects that in 2020, a significantly greater percentage of child abuse reports required *immediate intervention* due to the *high acuity and severity* of the cases, as well as related spikes in parental substance misuse, opioid overdose, suicidality, and incidents of domestic violence where were children present.³

The pandemic comes atop the trauma and economic impacts that families have endured from recurring disasters since 2017. The compounding impact of ongoing and recurring traumas on

children's social-emotional development has resulted in chronic stress and anxiety for many children and a corresponding decline in countywide school readiness scores, as well as an everwidening, extreme disparity between the school readiness of white and Latinx children⁴. Young children with special needs, dual language learners and those lacking adequate access to virtual learning have experienced serious disruption in learning, as well as the critical nutrition, counseling and other supports that many children normally receive at child care or school.

The pre-existing crisis in our community's child care sector has been significantly worsened by the pandemic. With permanent closure of dozens of child care providers, our communities have lost thousands of child care slots which will cripple parents' ability to return to work and slow down our local economic recovery.⁵

Across the state, pediatric well-child visits were down an estimated 24% from pre-pandemic baselines in December 2020 and the number of childhood vaccination doses administered to California children dropped by more than 40% at the start of the pandemic.^{6 7} This has especially impacted children covered by MediCal and is a huge blow to critical preventive care and early identification of developmental and social-emotional issues for young children.

The good news is that the County of Sonoma and our City/Town Councils of Santa Rosa, Petaluma, Rohnert Park, Windsor, Healdsburg, Sonoma, Sebastopol and Cotati have an opportunity to buffer these impacts on young children and families by strategically investing the *American Rescue Plan Coronavirus Local Fiscal Recovery Funding*, a highly flexible funding stream intended to address COVID-19 impacts at a local level⁸.

To ensure that the needs of children and families are prioritized, we request \$5 million in combined funding across County and municipalities (3% of the ARP Local Fiscal Recovery Funding to our county) to ensure that children have supports to be healthy, safe, and ready to learn, as we emerge out of COVID-19. First 5 Sonoma and community-based partners have actively supported families and children during the COVID-19 crisis and we remain committed to ongoing recovery efforts. However, First 5 funds (Proposition 10, 1998) alone cannot meet the needs of our youngest children and their families. Additional local and flexible funds are critical to ensure meet young

Greetings!

Many thanks for including the topic and funding (\$315,000) of Safe Parking in your proposed budget for your Tuesday Study Session. SAVS has seen the value of stabilizing our unhoused who cannot utilize our shelters, and is committed to bringing about these resources for their betterment.

Overnight vs 24/7? During the budget hearings earlier this year, we encouraged you to consider spreading the responsibility for safe parking around to the entire City. You agreed, and the plan was to try to have a parking site in every district. Your staff reviewed the available city underutilized land, and presented options to you.

I don't think there was any doubt that we did not succeed in finding good sites. Until we can, my fear is that this funding, like the original \$20,000 which started the CHAP Program, will languish in search of the perfect political implementation.

We also must remind you that SAVS did not support safe parking in an "Overnight" design. We did that for years on our own site on McBride Ave, and supported it elsewhere in the City. What did not work about it was its inability to connect wraparound services from nonprofit and county services to clients whose only onsite availability was after dinner and before bed each night. It was not very easy to get these services workers to spend time away from their families in the evenings with our clients.

Nor was it productive to have to require our clients to drive around all day avoiding detection for driving vehicles which sometimes had registration or maintenance problems, and usually carried pets and all other possessions.

SAVS was then, and is even more now, interested in safe parking operated 24/7, and what was referred to as an "alternate site". A single site, capable of being designed to accommodate multiple housing uses. Neither a shelter, nor a permanent housing complex, it fills the largest need of our unhoused. More flexible than cabins, far less expensive than housing, we proposed a site which can accommodate cars, RVs, and modular units.

In order for the City to undertake this innovative approach, it will need to know that its resources include funding which could be sufficient. We are requesting that \$1 million be allocated from the any source at the City's disposal to whichever department or separate entity chosen by the City to administer homeless funding for FY 21-22. We are simultaneously asking the County of Sonoma to take the same action. We are aware that the County, City, and other governing bodies are attempting to coordinate and act regionally in the development of homeless housing and services. The Sonoma County System Continuum of Care, and the Renewal Enterprise District are both being discussed as central coordination and planning entities.

Your budget allocation adoption does not require those decisions now. What we are asking you to do is to decide that our City is committed to actively exploring collaborative planning and operation of alternate housing such as what we have proposed. The pathways from streets to permanent supportive housing and beyond are not a one-lane highway. And until we find the routes they can take, our clients will be lost, and we will not succeed.

I hear that the counsel is considering the possibility of providing a stipend to childcare providers who stayed open during the pandemic. I would like to strongly encourage this plan of action.

I have been in the childcare profession for 30 years and this has been by far, the most difficult year of my career. The amount of stressors between concern of the pandemic itself and following the guidelines of safety set forth by the county while still trying to keep our school running was immense. After 35 years of serving families, Childkind where I am currently the director, was in jeopardy of closing. We persevered, but only because I was able to retain and hire dedicated staff who were willing and able to be on the front lines with me and provide a safe and nurturing space for young children to come, so their parents could work. The financial and emotional toll it is taking on all in the field is huge and although many are feeling safer going to work these days, our youngest children are still a ways away from getting vaccinated. Therefore, we are continuing to put our own and our families health on the line by coming to work every day. As you probably know, there is no such thing as social distancing with toddlers, and mask are being worn, but are a little bit of a misnomer for young children as they are often needing to be replaced and fixed and put on by our caring staff.

A stipend would be a token of gratitude to these very dedicated staff. I hear word of other centers who are trying and being unable to hire staff in this climate and I am worried every day that I will loose a teacher to a higher paying field and be unable to fill their spot, leaving families without care. Financial stability equals staff stability equals quality teaching and care for young children equals a healthy workforce of working families.

I truly hope you make the choice to do what you can to show these under appreciated, and underpaid essential workers, that they are needed and valued.

Under international law, even convicted murderers must be provided a sheltered, secure cell, food, water, and hygiene facilities.

Under U.N. rules for humanitarian response to refugees of war, famine, or natural disaster, all refugees are to be provided with at least:

- a secure site,
- tent,
- food,
- · water, and
- cooking and hygiene facilities.

Every city and county in the U.S, including Santa Rosa, should have a policy requiring the same here for all unhoused people. Every person must be provided a safe, and reasonable accommodation alternative, as needed, to living on the street. Non-congregate shelters are best for this purpose.

The emphasis should be on separate, private, non-congregate shelter rooms or tents, for

- safety,
- dignity,
- privacy,
- privacy and autonomy at one's bed or in one's room to take care of one's health, and
- to prevent enormously costly, devastating kickouts of sheltered people.

(Congregate shelters result in staff and residents being in everybody else's private business, down to the manner of cutting one's toenails; resulting in a greater number of costly, wasteful, devastating kickouts.)

Regarding "sweeps," please bear in mind:

- The police actions to evict homeless campers from their sites are weekly now. They do not help homeless people. Every camp site eviction adds to the trauma of people on the street.
- Evictions interfere with campers making progress toward getting housed.
- Evicted campers must spend days or weeks finding a new location, new tent, bedding, supplies, toilet options, access to food and water, etc. All while on foot. Only to be evicted again.
- This is a terrible abuse of penniless people.
- It increases the likelihood of criminal activities and sexual exploitation to pay for their necessities.
- We need solutions that keep people safe and give them a legal place to sleep.

The money we spend on these evictions would better fund safe parking and safe camping sites.

• Homeless people are our neighbors. To ignore them and torture them with camping evictions is inhumane.

Please <u>urgently plan, with people with lived experience of homelessness</u>, a safe parking and camping pilot site in every district, NOW!

Please

- set aside at least \$1,000,000 in the coming year for new and innovative homeless solutions.
- Fund \$315,000 for a Safe Parking Pilot Program where wrap-around services can be provided and the program can be 24/7.
- Topic 1: Safe Parking \$315,000 for a Safe Parking Pilot Program (Overnight)
 - We are pleased to see safe parking recommended as a homeless services program funded by the city.
 - However, overnight safe parking is not enough; the program must be 24/7 Safe parking. Overnight
 parking services a tiny subset of the unsheltered population with working vehicles, but this type of
 program limits access to homeless services that would result in transitional housing and ultimately
 permanent housing. This type of program is very disruptive, with cars coming in every night,
 leaving every morning. It puts a lot of stress on an already stressed population.
 - 24/7 safe parking is a cost effect solution it uses existing "housing" such as cars and RV's and is
 quick to implement. Safe parking programs require very little infrastructure some portable
 bathrooms, showers, and security fencing to become operational. Residents can help operate the
 program.
 - The initial recommendation to the board was for up to 7 sites to be created with the funding. It is our recommendation that 1-2 sites be created and that the site not be put in public parks or near schools. There are many private and public parking lots in commercial / industrial lots that are good places to open safe parking sites.
 - Safe parking is also a smart starting point for a more complete village safe parking is expandable and can morph into a village as public or private funding becomes available.
- Topic 2: Sam Jones Annex \$713,000 for the Sam Jones Annex (21-22 paid for by CDBG, future years by General Fund)
 - What are the city's plans for the Sam Jones Annex? It has put large sums of money into expanding the Annex, but replicating the shelter bed model does not seem like a great use of the site as many unsheltered people do not choose shelter beds as a housing solution.
 - We would like to see a new concept for the site as well as opening up the services contract to new innovative service providers like SAVS or equivalent.

Dear Council Members:

I am asking you to please consider using federal funds to support our childcare providers and early childhood educators who worked without hazard pay or safety of vaccination during the start of the pandemic.

Studies have shown that investments in early education set the foundation for learning, ensure school readiness and narrow the persistent achievement gap. I would like to make the case for the importance of investing in those professionals who are out in the field, doing the work and making the difference for these children and families. Those in the field are often undervalued and underpaid for the services they provide. These services are critical, we need to be asking ourselves how we can better support this workforce.

When everything shut down in March, centers and programs closed, leaving parents in an almost impossible position of trying to work from home, with young children at their side. Essential workers had no option to work from home and had to scramble to try to find alternative care. Many centers and programs in Sonoma County closed, due to the fear of the virus, or because they simply could not afford to operate their programs with a fraction of enrollment along with the costs of additional PPE equipment and cleaning supplies. Others, after careful consideration and review of recommendations placed by The Department of Social Services and the Department of Public Health decided to open their doors, understanding the need to get our local workforce up and running, and to keep our economy thriving. Those in the field also realized the importance of the social emotional development of the children, these children needed to have some return to normalcy and get back to learning and playing.

The ECE workforce was scared to go back, they worried for their health, they worried about their families health, yet they showed up. They got children back into programs and parents back to work. These are heroic efforts that deserve some recognition.

While a stipend of \$1,250 may not seem like a lot of money to many individuals living in Sonoma County, I know it would make a world of difference for many of our hard working, professional teachers and providers. The money would be appreciated, but more so the recognition that we, as a county support and value them as the professionals they are. Please support these individuals who did such important work during such scary and uncertain times.

I am writing to voice my support for a city funded safe parking program, but with two key changes to the initial recommendation. The initial description of the program emphasized overnight parking in seven spots across the city. Overnight parking is not a good solution for Santa Rosa because safe parking only allows moveable vehicles to pull in at night and leave in the morning. The significantly lowers the number of people that can receive services and the services that could be offered to the people using the safe parking program. Without the stability of a place to stay and supportive service, those in overnight parking have a slim chance of gaining stability and progressing towards permanent housing. I also do not think that seven spots spread out across the city is an efficient design. It would be better to have 1 or 2 24/7 safe parking sites - serving more than could be served among 7 sites more efficiently. So, please, yes lets do safe parking!! But lets make it 24/7 with wrap around services and in 1 or 2 locations where services can be delivered efficiently.
