



PROJECT NAME - SANTA ROSA FARM GROUP CANNABIS CULTIVATION FACILITY

PROJECT ADDRESS - 800 YOLANDA AVE, SANTA ROSA, CA 95404

PROJECT DESCRIPTION - Proposal to develop a commercial Cannabis facility on a \pm 5.5-acre site. Proposed development includes demolition of existing structures and construction of a 3-story, \pm 116,700 square-foot (sf) industrial building. Onsite improvements include hardscape for vehicle and pedestrian uses, and landscaping, including tree replantings as mitigation for removal of certain existing trees. Land uses approved by Planning Commission Resolution No. 12052 on April 8, 2021. The application has been filed by THE SANTA ROSA FARM GROUP. File No. DR17-078
