#### 8. SCHEDULED ITEMS

PUBLIC HEARING - SONOMA ACADEMY PERFORMING ARTS CENTER, MITIGATED NEGATIVE DECLARATION - DESIGN REVIEW MAJOR - 2500 FARMERS LN - FILE NO. DR20-019 BACKGROUND: Modification to a previously approved 17,984 square-foot Visual and Performing Arts building located at 2500 Farmers Lane as part of the Sonoma Academy campus. The previous project was approved on April 21, 2016, by the Design Review Board. The modification includes a new 18,187 square-foot building located at the same approximate location, with an updated architectural design. The project is within the scope of the 2005 Mitigated Negative Declaration and no additional environmental review is required in accordance with CEQA Guidelines Section 15162.

Senior Planner Adam Ross gave the staff presentation.

Vice Chair Hedgpeth opened the public hearing at 5:08 pm.

Leslie Mantufal - Expressed concerns re: construction hours and noise, including parked/idling vehicles; expressed concerns about the large concrete wall.

Martin Seeger - Expressed concerns re: construction noise: trucks arriving early and parking/idling, horns, music, slamming cab doors. Asked for a more restrictive noise agreement. Previous project design/appearance was a country barn, current appearance is a concrete wall. Consider color on the wall instead of stark white.

Steve Osborn - Expressed concerns re: ongoing noise and amplified music. Amplified instruments can be heard all over the

neighborhood because windows must be kept open due to Covid. Will new auditorium be sound proofed?

Vice Chair Hedgpeth closed the public hearing at 5:20 pm.
