What is an Unlimited Pass Program?

- Discounted bulk rate for an entire population of participants to have FREE access to a transit system
- Benefits:
 - Improving transportation equity
 - Increasing transit ridership
 - Improving school attendance
 - Reducing vehicular trips and parking demand
 - Supporting densification and affordability initiatives
 - Expediting bus boarding
 - Increasing transit's profile within the community









Why Unlimited Pass, why now?

- Pandemic recovery:
 - Economic support for Santa Rosa community
 - Promote transit as safe & reliable City service
- Ridership demographics
 - 86% of CityBus riders are low-income
 - 53% do not have access to a working vehicle
 - 28% are K-12 or college students
- Grant funding available to support program
- Aligns with Council and region's goals of affordability and sustainability

Examples of Unlimited Pass Programs

- Widely utilized in the university setting throughout CA and the county
- Supports transit for youth, employees, non-profits and residents of both affordable and market-rate housing developments
- Program models:
 - Santa Clara Valley Transportation Authority's SmartPass
 - Denver Area Regional Transportation District's EcoPass
 - Sacramento Regional Transit District's RydeFreeRT program for TK-12 grade youth


Five reasons to take the bus:

- 1. Economics: It's Free for Students
- 2. Environment: Reduce Your Carbon Footprint
- 3. Celebration: Avoid the parking situation
- 4. Personal Health: Get more exercise than car riders
- 5. Public Health: Connect with your community



Current unlimited free-transit programs

- Current free-fare program performance:
 - 17% of total ridership in 2019
 - 30,000 riders monthly
 - Growth rate exceeding that of the system as a whole
- SR Junior College
 - 15,000 riders/month prior to pandemic
- Paratransit Registrants
 - 4,200 free trips per month during FY19
- Veterans
 - 3,000 free trips per month during FY19
- City employees and children 4 and under
 - 3,400 riders per month in FY 2019



Unlimited Pass Program Benefits for Santa Rosa

Supports housing development

Reduction in Greenhouse gas

Recovery from the COVID-19 pandemic

Affordable transportation for residents, students, and employees

Supports the City's efforts and planning initiatives:

- Affordable Housing and Sustainable Communities (AHSC)
 Program
- Bay Area Commuter Benefits Program (SB 1128)
- Downtown Station Area Specific Plan
- SB 743 Implementation
- Climate Action Plans





Proposed Unlimited Pass Program Design

- Partnerships with employers, housing developers, institutions, non-profits with 50 or more participants
- Maximum Year 1 cost ceiling based on:
 - 4% of participants assumed to ride each weekday
 - One-time administrative charge of \$3,000
- Annual cost based on number of rides multiplied by \$0.75 - \$0.85/ride (CityBus average fare)
- Track ridership manually and using electronic media
 - In the future, use Clipper Card
 - Entity and City will be responsible for pass distribution and managing fraud
- Enter into financial agreements with each entity

Proposed Youth (TK-12th Grade) Unlimited Pass Pilot Program

- For 12th grade and under
 - Including youth not associated with school system
- Unique benefits
 - Reduced household expenses for families
 - Improved school attendance
- Outreach will continue to promote and evaluate the program
 - 7 school districts
 - Sonoma County Office and Education
 - Social Advocates for Youth (SAY) and other youth organizations
 - Private high schools
- TK- 8th grade no ID needed
- 9th -12th grade Use school ID or CityBus issued pass



Transportation Fund for Clean Air (TFCA) Funding

- Bay Area Air Quality Management District program funded by a \$4 surcharge per car or truck funding projects that reduce on-road motor vehicle emissions
- Sonoma County Transportation Authority (SCTA)
 awards annual formula allocation to Santa Rosa
 CityBus for projects that improve local air quality
 - Funds restricted to a narrow range of uses and subject to annual review of cost effectiveness in reducing GHGs
- \$250,000 in TFCA funds available in existing grants to support Unlimited Pass Program and TK-12th grade unlimited pass pilot program



Program Funding and Seeding

- No impact on the General Fund
- Unlimited Pass Program to use TFCA funds to seed partnerships with employers, housing developers, institutions, nonprofits;
 - 1st year up to a 50% match
 - 2nd year up to a 25% match
 - 3rd year up to a 10% match
- TK-12th grade unlimited pass pilot to be funded by TFCA for 18-months
- Potential new revenue from partnering entities
- Over time program will be fine tuned to be self-sustaining and expand transit revenues



Program Kick-off, Implementation, and Evaluation

Kick-off proposed for July 1st, 2021

Implementation

- TK 12th grade unlimited pass pilot program:
 - Develop promotional campaign
 - Continue outreach to school districts & youth organizations
- Unlimited Pass Program:
 - Establish agreement template
 - Develop promotional campaign and develop as City tool in menu of transportation mitigation strategies
- Track ridership for each program initiated
- Conduct billing for grant funds and partner entities

Evaluation and Program Development

- Evaluate benefits and cost-effectiveness
- Conduct surveys of program participants
- Identify long-term funding for TK-12th grade program
- With success, expand the programs beyond Santa₁Rosa

Recommendation

It is recommended by the Transportation and Public Works Department that the Council, by resolution,

- 1) establish the CityBus Unlimited Pass Program allowing the Transit Division to seek additional community partnerships to provide fare-free transit access,
- 2) adopt a methodology for calculating Unlimited Pass Program costs for participating entities,
- 3) delegate authority for executing Unlimited Pass Program partnership agreements up to \$100,000 to the City Manager or designee, and
- 4) authorize the Transit Division to initiate an 18-month grant-funded unlimited pass pilot program for TK-12th grade youth.
