



2021 Russian River Conditions

June 14, 2021: SWRCB Issued Order Approving TUCP Filed by Sonoma Water May 14, 2021

- Water Year Type in upper watershed is **CRITICAL**
 - Minimum Instream Flow: Upper Russian River 25 CFS (no change)
- Water Year Type in lower watershed is **CRITICAL**
 - Minimum Instream Flow: Lower Russian River -35 CFS (reduced from 85 CFS)
- Diversions are to be curtailed 20% over 2020 usage (Contractors to receive allocations) beginning July 1


2021 Sonoma Water Temporary Urgency Change Petition

Upper Russian River management

- Sonoma Water shows critical levels projected in Lake Mendocino by October 1 (20,000 AF)
 - Junior Water Rights were curtailed June 1
 - Water Rights curtailment Healdsburg (40% / budget 74 GPCD)

Lower Russian River management

- Target storage for Lake Sonoma is >100,000 AF by October 1
 - Allocations to be issued for contractors
 - Reporting and monitoring of activities



June 12 2021

- Very Successful
- Estimated 1500+ "drought kits" delivered by Santa Rosa Water staff at Fairgrounds
- SMSWP hosted 16 locations in Mendocino, Sonoma and Marin Counties
- More events in Santa Rosa planned in August and September





Next Steps

- Identify final contractor allocations (July December 2021)
- Institute Mandatory Stage of the Water Shortage Contingency Plan (Adopted June 8, 2021)
 - Likely Stage 3 up to 20% reduction
- Continue aggressive water use efficiency activities, outreach and tracking of metrics




