Please be advised that at the regularly scheduled Planning Commission meeting to be held on Thursday – June 24, 2021, at or after 4:00 PM, Planning staff will provide clarification on the address of the existing Crown Castle telecommunications tower, which is incorrectly listed as 135 Ridgway Avenue, and the proper location of the tower to be removed is at 1500 Armory Drive in Santa Rosa.

## 9-1. PUBLIC HEARING – CROWN CASTLE RELOCATION PROJECT, EXEMPT PROJECT - CONDITIONAL USE PERMIT - 1236 CLEVELAND AVE - CUP20-074

Planning Staff received communication from CAL FIRE Staff indicating that the Crown Castle Telecommunications Relocation Project incorrectly listed the 135 Ridgway Avenue address when in fact the correct address is 1500 Armory Drive in Santa Rosa. The error is likely due to the City's Geographic Information System (GIS). However, the location of existing telecommunications tower to be removed is still in the same approximate location and the new telecommunications tower located at 1236 Cleveland Avenue is correctly labeled. Attached to this memo is an email correspondence with CAL FIRE representatives, City Staff, and the applicant team.

I have spoken to the CalOES Public Safety Communication (PSC) and verified that the green circled tower is located at 135 Ridway and only has CAL FIRE and CHP radio equipment. It is part of California's Microwave Backbone.

The blue box is incorrect in determining the property line. I have already contacted City of Santa Rosa last year that the GIS information is incorrect, we deeded property to the National Guard back in the 1980's, which might add to the confusion here. Our property ends at the wood fence.

The Project Address is wrong. Please have the Applicant confirm the correct address on the lease, MOU or other documentation.


