I am a lead fire warden in one of the apartment buildings at Spring Lake Village. I am responsible for helping to evacuate a number of residents if an evacuation becomes necessary. I was on duty during the evacuation of September 2020 and was the last of the building's residents to leave.

When I left I could see the Glass Fire coming toward Spring Lake Village. I had to take Montgomery Drive west toward downtown Santa Rosa. Traffic moved so extremely slowly that I wondered if the line of vehicles could possibly get away from the fire before it overran us. Fortunately firefighters held the fire at Highway 12 for the most part but not entirely.

Now Covia Communities proposes to construct more housing in the area affected by the Glass Fire. There seems to be no provision for evacuating more people yet from an area that already lacks adequate escape routes in the event of another fire. Hence the Covia proposal appears unrealistic and short-sighted given the current state of overloaded evacuation routes.

Before approving the Covia application, it seems wise to do something about the inadequate evacuation routes. Such an approach would require the coordination of Caltrans, the County of Sonoma and the City of Santa Rosa to improve evacuation routes before approving the construction of additional housing units in a fire zone.

I note that the proposed Elnoka development would add about ten times the number of residents to the same area as the Covia project. I do not believe that either project should be approved absent improvements in evacuation routes.

I encourage the Planning Commission to reject both projects at this time.

Impact AQ – 3 Future potential development projects associated with the proposed project could cumulatively contribute to the non-attainment designations of the San Francisco Bay Area Air basin.

Impact QA – 6 despite implementation of the proposed project policies criteria air pollution emissions associated with the proposed project could generate a substantial net increase in the emissions that exceeds the Bay Area Air quality management District regional significant thresholds

I have been a resident home owner at 338 Los Alamos Road since May 1996. In that time there has been a huge increase in traffic on the small section of Los Alamos Rd. between Highway 12 and Melita as drivers now use Melita to avoid lights on westbound Hwy 12.

We have had frequent evacuation orders during fire danger since 2017. I am very worried that if there is an entrance on Los Alamos to the new units proposed it will be impossible to evacuate Villa Los Alamos quickly. Perhaps if the new SLV entrance were only on Melita Rd? Los Alamos Rd. is much too narrow, and the turn onto it from eastbound Hwy 12 is not well banked.
