Item: 14.2 REPORT - CHARTER REVIEW - ESTABLISHMENT OF CHARTER REVIEW COMMITTEE, PROCESS AND ISSUES FOR 2022 CHARTER REVIEW BACKGROUND: The City of Santa Rosa is a Charter City formed pursuant to the provisions of the California Constitution. The City's Charter provides the fundamental framework for the City's governance. It is, in essence, the City's "constitution." The City Charter is subject to periodic review for possible revision or refinement. Any proposed amendments to the City Charter are subject to approval by the City's voters. Section 12 of the City Charter requires review of the Charter not less than every 10 years, with the review to be conducted by a committee to be appointed by the City Council. The last Charter review began in 2011 and resulted in proposed revisions placed on the November 2012 ballot. In accordance with Section 12, the City Council has directed that a new Charter review begin this fall. On June 8, 2021, and again on August 3, 2021, the Council held study sessions to consider the timing, process and scope of the Charter review. Council gave direction to the City Attorney to move forward with Charter review and asked staff to return to the Council on August 17th for formal action to establish the Charter Review Committee and to set forth the process and issues for Charter review in accordance with the Council's direction. RECOMMENDATION: In accordance with Council direction, it is recommended by the City Attorney that the Council, by resolution: 1) direct that a Charter Review Committee be formed, comprised of 21 city residents, with each Council Member appointing three members to the Committee; 2) establish a method for appointment of the Chair of the Committee; 3) direct that the Committee commence its work as soon as feasible; 4) identify topics to be included for the Committee's consideration; and 5) make such other recommendations regarding the Charter review process as the Council deems appropriate.

Dear City Council Members and City Staff Members:

I am encouraged to see that the City is considering options for keeping Bennett Valley Golf Course in operation after June of next year. I am a Santa Rosa resident and a regular golfer at Bennett Valley. I was also a regular user of the restaurant while it was open and a monthly user of the event facility when it hosted the Sons in Retirement group until the facility closed.

All of those facilities, and in particular the golf course, are important parts of life in Santa Rosa for many residents. Their loss would be a big blow to Santa Rosa's civic life.

I know several members of the SBVGC non-profit group, and I have confidence in them to represent my viewpoint with the City. At least one of them should be part of the selection process for hiring a consultant to study what needs to be done to keep the course in operation as well as the process of providing information and input to the consultant.

In the review of plans to continue the golf course and restaurant/event facility, I would respectfully suggest that it might be appropriate to evaluate to what extent the restaurant/event facility is really affiliated with the golf course and to what extent it is really an independent facility. Connected with that is the question of the extent to which the golf course should be responsible for paying for expenses related to the event facility. Properly allocating those expenses may make it easier to obtain someone to operate the golf course. The restaurant definitely served golfers, but the event facility only did so very indirectly, if at all.

In reading Jason Nutt's staff report to you he continues to feed you the same old lies and misinformation so, I must repeat information I gave you back in February. The Event Center/restaurant is not now, nor has it ever been, a "clubhouse" for golfers. It was called a "clubhouse" by the, then, city council to justify using the golf course enterprise fund to eventually pay for the entire project. I think it is the responsibility of this city council to unburden the golf course of the remaining debt owed for the Event Center and direct the city CFO to pay off the balance.

After all, the "clubhouse" is not contributing very much to the golf course enterprise fund. This entire process should be done right, unlike the actions of the 2005 council.

I think the council should look very carefully at the Request for Proposals being submitted for your approval by "Staff" so that it covers JUST the operations of the golf course and the event center/restaurant and doesn't waste time evaluating the golf and restaurant business in general. I, also, think you should require any consultant to sit down with the expert members of Save Bennett Valley Golf Course (SBVGC). They are a 501( C )(3) non-profit with as much or more expertice than any consultant you might hire. Additionally, I think one criteria for a consultant should be that they be a local company since they would be far more familiar with this specific situation. Along those lines, I think the proposal selection committee should have a member of the golfing community and a member of the general public to evaluate the event center proposals. As you may know, just the Facebook group of SBVGC has well over 4,000 members and you may be hearing from some of them shortly.

Another reason to hire a local consultant is the fact that the city, for years, has promoted "GO LOCAL". You even have a city web page with links to local businesses. I think it would be good if the city council joined this effort.

Lastly, I do appreciate how busy the council is but, I think item #4 under "Staff Recommendations" should be changed. I think any modifications should come back to you for review. Especially since the current city manager is interim.
