Good morning Mr Kolin,

Thank you for taking the time to acknowledge along with adding discussion to the Aug 31st agenda per the vaccinee or testing mandate concerns that Andy has brought to your attention in the hopes to vote against placing this mandate onto our employees.

As a Union Rep for units 4, 6 & 7, I can confirm that there are many other employees who have come to me with these same concerns. Andy is not alone.

Per this possible future mandate, along with the question of why we would only be testing non-vaccinated employees while vaccination status does not change the fact that you can be vaccinated and still get covid and or infect someone else vaxed or not, would everyone who has been vaccinated be considered not fully vaccinated because of needing a booster, and subject to weekly testing also?

I have also been asked about the testing procedure itself. It has been brought to my attention that

the covid testing swabs are shown on each package to be sterilized with EO (Ethylene Oxide, which is a carcinogen, causes cancer, damages DNA and fertility). As a person who has just undergone treatment for nose cancer this last year, and if I was one to be subject to weekly testing with this information, I would be reluctant with legitimate concerns. As City employees, we have been trusted for years not to come in to work if we are sick. Now for the last year and a half, we have been trusted to social distance, wear our masks and to self-check with the SoCo health app each day. As we watch protests and riots breaking out in the news, we can all see this is tearing our Cities, Counties and Country apart.

As Andy commented and others have contacted me about, if the City is really concerned about the safety of their employees and ends up deciding to follow this mandate in some sort, we should be testing all or none. And if we do indeed start testing, maybe there is an alternate way to test that can be safer. There are many articles on the web about saliva testing being a game changer. Good morning Jeff and Jason,

It is my understanding from your communication below (and others) that the City is considering a COVID policy similar to the one Sonoma County just approved at their 8-17-21 Board of Supervisors meeting titled, "COVID-19 Vaccination and Testing". If the intent of this policy is to reduce the transmission of the virus, it may not accomplish that goal. Their policy is only testing the unvaccinated. It seems to ignore the mounting evidence that the virus is spreading even among the vaccinated. The efficacy of the vaccines appears to be declining over time. This means that even vaccinated persons are not only carrying the virus, shedding and spreading it, but are also getting sick. At the Board of Supervisors meeting yesterday the presentation indicated that approximately 20% of the hospitalized patients were fully vaccinated. They seemed to downplay it, without any consideration that it may get worse.

Then, as if to confirm my skepticism of yesterday's meeting and their approved polity, today's Press Democrat reported the following:

August 18 Press Democrat, "Officials said it is "very clear" that the vaccines' protection against infection wanes over time, and they noted that Israel has begun seeing a worsening of infections among vaccinated people. They said the U.S. needs to get out ahead of the problem before it takes a more lethal turn here and starts leading to hospitalizations and deaths among the vaccinated."

It seems that a policy that only tests some employees while not testing others will fail to achieve the stated goal and may be a waste of time and effort. The City may be better off testing all, or none. At least if none are tested the employees will be diligent about keeping an appropriate social distance rather than being lulled into a false sense of security.

Note: I am speaking for myself. I do not represent the Union.

Greetings Council,

Thank you for taking the necessary measures to protect our S.R. City staff by requesting either proof of vaccination or weekly testing for COVID-19. Please continue to allow our staff to make their own choices regarding their personal health decisions for the entirety of the pandemic.

As an amateur bodybuilder, I exercise intensely each day and eat extremely healthy. While I take regular precautions to protect my health, the average American does not.
