Chair Weeks and members of the Planning Commission,

The purpose of this email is to respond to questions raised by Planning Commissioners regarding the building color and the signage for Item 9.1 - CR SANTA ROSA, LLC (dba: Cookies Retail), scheduled for review today.

Planning staff requested additional clarification from the applicant regarding the proposed signage. The attached information includes an example of the proposed color and analysis of signage provided by the applicant. Staff has completed review of the additional information provided for compliance with Section 20-46.080(F)(10). Staff notes that (1) the proposed project location is not located within 1,000 feet of a daycare center, school, playground, or youth center; (2) the proposed signage and building color(s) would not advertise cannabis products; and (3) the proposed cannabis retail/dispensary operation would be staffed with at least one security guard or reception person who would only allow on the premises persons who are 21 years of age or older and who possesses a valid government-issued photo identification card.

Planning staff concludes that proposed future signage that is consistent with the project information presented to Planning Commission would comply with Cannabis Ordinance requirements.

The requirement that a cannabis retail facility cannot advertise within certain facilities frequented by minors applies to advertising signs, i.e. off-site billboards. The requirement in Santa Rosa's cannabis ordinance is identical to the state law regarding the location of off-site billboards. Cookies does not propose any advertising billboards, just on-site signs identifying the business like any other retailer.

That being said, we researched and can confirm that the store is not within 1,000 feet of a day care center, school, playground, or youth center. A member of the Cookies team prepared a sensitive use analysis that studied an area within a 600-foot radius and a 1,500-foot radius of the store. It shows no daycares, schools, playgrounds, or youth centers. It is attached as **Exhibit A**.

Pursuant to California law, Cookies does not advertise or market cannabis products to encourage minors or in a way that is attractive to children. The brand was created by a popular Mexican-American music artist, Berner, with origins in the Bay Area. The brand has been approved in other jurisdictions throughout California that are subject to the same state law regarding advertising that appeals to minors. They include Oakland, Hayward, Sacramento, Modesto, Merced, Coalinga, Redding, Lompoc, Woodland Hills, Santa Ana, San Bernardino, San Diego, and La Mesa.

Cookies is also approved in other highly regulated states with similar rules, including Oregon, Washington, Massachusetts, Nevada, and Colorado. Please see a chart attached as **Exhibit B** summarizing other states where the Cookies trade name and logo, and accompanying packaging and advertising, are being used without any issue.

Just as important, Cookies has significant protocols in place to ensure that minors are denied entry into the store and do not come into possession of any cannabis products. They are captured in the security plan, and we can explain them in detail on request. All webpages have an age gate on them, so no child under 21 should be accessing the website.

We believe the Cookies brand, name and logo are not directed towards minors and there is significant evidence to support our compliance with Santa Rosa and California law.
