1. Project, Goals, Objectives, and Beneficiaries

The goal of the Fulton Day Labor Center Renovation Project is to create a greater sense of community, dignity, and pride around this critical community service center serving Santa Rosa employers and day laborers. One objective is to increase awareness and utilization of this employment and safety net program through capital improvements which will improve both safety and aesthetics. Another objective is to increase employability of clients by providing them with opportunities to learn and practice gardening skills, the most common job dispatched. The renovation project includes the installation of planters and plants on the premises to facilitate the development of these high-demand job skills. Capital renovations include the purchase and installation of an outdoor sign: *California Human Development Fulton Day Labor Center*, furniture that can be used outside and disinfected, lighting, a doorway awning, planters, soil and plants, drip irrigation, and outreach and Open House materials.

Opened in 2013, California Human Development's (CHD) Fulton Day Labor Center provides a safe and dignified place where day laborers can meet with employers for an honest day's work at fair pay. CHD center staff also distribute safety net and emergency supplies and services including food, clothing, and personal protective equipment. Staff connect clients to Englishlanguage classes and job skills training to increase their employability. Typical jobs dispatched through the center include landscaping/gardening, construction, building, and demolition, moving (residential and business), agricultural or bottling, suckering, and harvest, house maintenance, house cleaning, and outdoor cleaning as well as seasonal and event projects such as disaster clean up. With a mission to break the cycle of poverty for Northern California's vast population of migrant and seasonal farmworkers, CHD was created in 1967. Our Fulton Day Labor Center helps low-income Santa Rosa residents obtain employment and greater financial stability. This program helps to empower individuals to pursue and achieve the American Dream--building successful lives, families, neighborhoods, and communities.

The COVID-19 pandemic has been particularly devastating to an already vulnerable population which this project serves: low-income minorities and immigrants struggling for survival in our very own community. The CHD Fulton Day Labor Center is located on Second Street, one block west of downtown Fulton. Fulton is a rural, census-designated place in Sonoma County just north of Santa Rosa city limits. The day labor center serves approximately 100 individuals annually, mostly Hispanic/Latinx males who are Santa Rosa residents ranging in age from 18 to 70. Almost all of our clients, and many of our employers who hire them, are repeat "customers" depending on us to facilitate this connection in a safe, professional, and dignified manner. By connecting 100 individuals to consistent employment, we are indirectly serving their families, so at least 300 Santa Rosa residents (approximately 75 clients with four family members on average) are served annually. The wages earned support the economic development of the community enabling residents to pay rent and shop for food and other staple household items.

Keeping this population working and off the streets decreases public loitering and increases safety. Our community has an economic and civic obligation to support hard-working immigrants seeking a better life for themselves and their families.

The land is privately owned by Rami Batarseh of Batarseh Investments, LLC (please see attached letter). The building is owned by California Human Development. The aforementioned capital improvements do not require any specific approvals or permits from Santa Rosa City or Sonoma County.

2. Outreach

Outreach will include: 1) an Open House ceremony which will include invitations to residents living in the neighborhood in which the day labor center is located as well as to funders and supporters of the renovation project, 2) announcements via CHD's electronic media channels including social media (Facebook, Twitter, LinkedIn), CHD's website, and CHD's internal and external quarterly e-newsletters, 3) flyers posted throughout Fulton and Santa Rosa in places frequented by our target population including ethnic markets, churches, parks and other social service organizations, and 4) word of mouth.

3. Community support

The Fulton Day Labor Center is so much more than a day labor center. Our community partners, St. Joseph and Alliance Medical Center, regularly provide us with COVID safety information, supplies, testing and vaccinations on the premises for our clients. Our day labor center is a Redwood Empire Food Bank (REFB) distribution site, and we distribute free, nutritious food to needy families on the first and third Tuesday of every month (please see attached REFB letter of support). Before COVID we accepted donations of clothing and toys from private citizens and churches for distribution at our day labor center. Partners and private individuals have told us that they are very much in favor of our renovation project and will help in any way they can. Local businesses including wineries rely on our workers who have a reputation for being hardworking and professional. CHD has an excellent reputation in our community and looks forward to increasing business access to our local workforce during this pandemic and beyond. CHD's dedicated staff often volunteer their personal time at CHD and community fundraisers and events. In fact, some CHD employees who reside in Santa Rosa regularly utilize the Fulton Day Labor Center for their own home and garden tasks. In addition, our day labor center clients are referred to CHD's Immigration and Citizenship program for information and assistance as well as to CHD's CARES program for linkages to disaster recovery resources. Financial support is being sought from the County of Sonoma Community Investment Fund Program as well as from online and private donors (as needed) who feel passionately about supporting this target population.

4. Maintenance

Not applicable. Day labor center staff will periodically boost soil nutrient levels in planters and swap out plants as needed.

5. Eco-Friendly

CHD will use eco-friendly materials and supplies to the extent possible given budgetary constraints.

6. Safety

CHD adheres to all CDC and local government regulations and recommendations for maximizing safety in relation to the current pandemic. We strictly enforce mask wearing, even outdoors around the facility, encourage frequent sanitizer use, and enforce social distancing. Canopies and grant-funded heat lamps will enable outdoor meetings and trainings during cooler weather.

7. Budget

The Fulton Day Labor Center Renovation Project budget is \$5,000 and includes Furniture or two benches at \$163 each or \$326 total, two tables at \$206 each or \$412 total, 10 chairs at \$63 each or \$630 total for a Furniture subtotal of \$1,368. Materials include one awning at \$420, one sign at \$800, six planters at \$90 each or \$540 total, four lighting units at \$79 each or \$316 total, and two heat lamps at \$150 each or \$300 total for a Materials subtotal of \$2,376. Garden supplies include drip irrigation at \$200, 30 plants at \$25 each or \$750, 10 bags of soil at \$10 each or \$100 for a Garden subtotal of \$1,050. Finally, outreach includes an Open House ceremony and the printing and distribution of flyers which we estimate to cost approximately \$206 in total. This CAB grant request is for half of all expenses listed (all are eligible according to grant guidelines) and, if awarded, this \$2,500 will be matched by \$2,500 from a Sonoma County Community Investment Fund grant. Should California Human Development not be awarded grant funding, the Fulton Day Labor Center will submit an internal funding request to cover project expenses with funds from CHD's general, unrestricted account and/or an online crowdfunding fundraiser.
