### 4. APPROVAL OF MINUTES

#### 4.1 March 5, 2018 Regular Meeting Minutes

### 5. SCHEDULED ITEMS

#### 5.1 PROCEDURES FOR EVALUATING AND ACCEPTING GIFTS OF ARTWORK IN RESPONSE TO THE FIRES

Staff will present a draft of procedures for evaluating gifts of artwork and criteria for reviewing artwork related to the fires.

Recommended Action: Discussion

Staff stated the goal today was to have a discussion about utilizing existing procedures and criteria for evaluating gifts of artwork in general, not just in response to the fires. Feedback from the APPC will be noted and action to approve a final draft will be placed on the next meeting agenda. Staff reviewed 'Procedures for Gifts to the Public Art Collection' draft and discussion ensued.

**Recommended Action: Information only**

Staff presented photos of artworks that were recently restored by SF Art Conservation. The artwork for Depot Park is in its final design phase with revisions being made based on selection panel and APPC feedback. Final design will be presented to APPC in June. Meter Made is in process with a cement pad completed and several meters installed on the art piece. A new Public Art Map has been installed at the Courthouse Square kiosks, featuring 59 artworks and a QR code linking to a mobile version viewable on smart phones.

**6.1 PRESENTATION BY COMMITTEE MEMBER YOUNGLOVE**

Board Member Younglove presented online images of participatory art hosted by Morningside Lights, and a group called Superior Concept from Columbia University in New York City. The group offered free workshops to all ages, teaching the crafting and operation of puppets and lanterns, culminating in a procession of lighted artwork after sunset with musicians and a feast.
