10.1 REPORT - STATEMENT OF SUPPORT FOR THE CITY OF SANTA ROSA'S HOUSING RECOVERY BOND

BACKGROUND: On July 24, 2018, the Santa Rosa City Council

approved a resolution to place a Housing Recovery Bond on the November 6, 2018 ballot. On August 16, 2018, the City of Santa Rosa drafted a ballot argument in support of the Measure. The Housing Authority has requested to take a similar action providing support for the Measure.

RECOMMENDATION: It is recommended that the Housing Authority, by resolution, approve a statement of support for the City of Santa Rosa Housing Recovery Bond that will appear before the Santa Rosa electorate on the November 6, 2018 ballot.

After a brief discussion, the City Attorney advised that this item be pulled from the agenda as the Housing Authority did not have authority to take a position on the housing bond as a legislative body.
